# Enterobacteria-secreted particles induce production of exosome-like S1P-containing particles by intestinal epithelium to drive Th17-mediated tumorigenesis

## **Abstract**

Gut-associated inflammation plays a crucial role in the progression of colon cancer. Here, we identify a novel pathogen-host interaction that promotes gut inflammation and the development of colon cancer. We find that enteropathogenic bacteria-secreted particles (ET-BSPs) stimulate intestinal epithelium to produce IDENs (intestinal mucosa-derived exosome-like nanoparticles) containing elevated levels of sphingosine-1-phosphate, CCL20 and prostaglandin E2 (PGE2). CCL20 and PGE2 are required for the recruitment and proliferation, respectively, of Th17 cells, and these processes also involve the MyD88-mediated pathway. By influencing the recruitment and proliferation of Th17 cells in the intestine, IDENs promote colon cancer. We demonstrate the biological effect of sphingosine-1-phosphate contained in IDENs on tumor growth in spontaneous and transplanted colon cancer mouse models. These findings provide deeper insights into how host-microbe relationships are mediated by particles secreted from both bacterial and host cells.

#### Introduction

Dysregulation of the interactions between the gut epithelium and intestinal bacteria leads to the loss of host immune tolerance and promotes the development of colon cancer<sup>1</sup>. The mechanism by which these interactions regulate host immune response during cancer progression has not been completely characterized.

Recently, the tumorigenic function of exosomes has become widely recognized<sup>2,3</sup>. However, the potential role of intestinal mucosa-derived exosome-like nanoparticles (IDENs)<sup>4,5</sup> in the regulation of the intestinal immune system of a colon tumor-bearing host has not been studied. Based on the characteristics of exosomes released from intestinal epithelial cell (IEC) lines, it has been suggested that IEC-derived exosomes influence antigen presentation<sup>6</sup> and antimicrobial responses<sup>7</sup>. However, because cell culture cannot completely mimic the microenvironment of the gut community of a host bearing a colon tumor, it has not been possible to determine whether the exosomes in the intestinal mucosa of a colon tumor-bearing host regulate the host immune response by communicating with intestinal bacteria. We hypothesize that, along with epithelial cells, intestinal bacteria and immune cells, IDENs in the intestinal mucosa play a crucial role in gut immune regulation. As a proof of concept, we used three well-established Th17-regulated colon cancer mouse models to determine whether IDENs under different pathophysiological conditions play a role in the induction of intestinal Th17 cells by communicating with enterobacteria (ET)secreted particles (ET-BSPs). In particular, we investigated whether IDENs contribute to the development of Th17-mediated colon tumors and whether the biological functions of IDENs can be altered through interactions with intestinal bacteria.

In this study, we find that sphingosine-1-phosphate (S1P) contained by IDENs mediates their effects and lead to the promotion of tumor growth through the induction of Th17 cells. The enrichment of IDENs with S1P is induced by ET-BSPs (Figure 1A). The intestinal macrophage PGE2 induced by IDEN<sup>CCL20+PGE2+S1P+</sup> further drives the overproduction of CD4+CCR6+IL17A+ cells in colon tumor—bearing hosts (Figure 1B). Using APC<sup>Min/+</sup> mice and MyD88-/- or APC<sup>Min/+</sup>MyD88-/- mouse tumor models, we further demonstrate that the MyD88-mediated pathway plays a role in the APC<sup>Min/+</sup> IDEN (APC-IDEN)-mediated recruitment and activation of CCR6+CD4+Th17+ cells. Collectively, IDENs communicate with the established mammalian gut community and regulate gut immune homeostasis. Dysregulation of the composition of IDENs (for example, the overproduction of S1P) promotes colon tumor growth.

## Results

#### Uptake of ET-BSPs by IECs leads to the induction of Th17 cells

Increasing the number of CD4<sup>+</sup>Th17<sup>+</sup> cells in animal models of colorectal cancer has been demonstrated to have procarcinogenic effects<sup>8–10</sup>. Published data<sup>11</sup> suggest that ETBF (enterotoxigenic *Bacteroides fragilis*) helps to induce the Th17 cell–mediated promotion of colon carcinogenesis. The mechanism by which Th17 cells are induced by ETBF is not completely understood. To investigate the role of ET-BSPs (here used to refer to ET-BSPs from enterotoxigenic *Bacteroides fragilis*) in the induction of Th17 cells and colon

inflammation, mice were given drinking water containing 3% DSS to induce colitis and were then treated with ET-BSPs. ET-BSPs accelerated the loss of body weight and reduction of colon length in mice with DSS-induced colitis (Figures S1A and S1B). When administered orally to DSS-treated mice, BSPs derived from nontoxigenic *B. fragilis* (henceforth referred to as 'NT-BSPs') offered significant protection against weight loss and reduction of colon length (Figures S1A and S1B), consistent with results by others <sup>12,13</sup>. Interestingly, NT-BSPs induce Foxp3<sup>+</sup>CD4<sup>+</sup> T cells, whereas ET-BSPs induce the accumulation of CD4<sup>+</sup>IL-17A<sup>+</sup> cells in the colon (Figure S1C). To identify which types of intestinal cells take up BSPs, we gavaged colitic mice with BSPs labelled with PKH26 dye. The resulting colon section images show that BSPs are associated with intestinal epithelial cells and macrophages (Figure S2).

The biological effects of ET-BSPs on the recipient cells were further investigated both in vitro and in vivo. ET-BSPs increased the expression of CCL20, COX-2 and genes encoding proinflammatory molecules in macrophages (i.e., IL-6, IL-23, TNF-a, and MMP9) (Figure S3). To determine whether macrophages exposed to ET-BSPs play a role in the induction of CD4<sup>+</sup>Th17<sup>+</sup> cells, OT-II naïve CD4<sup>+</sup> T cells were cultured with colonic macrophages treated with ET-BSPs or NT-BSPs in the presence of OVA. NT-BSP-treated macrophages induced the expression of IL-10 in macrophage-T cell co-cultures, whereas minimal IL-10 was detected in co-cultures of ET-BSP-treated macrophages and CD4<sup>+</sup>T cells. However, cocultures of ET-BSP-treated macrophages and CD4<sup>+</sup> T cells had higher quantities of IL-17A and IL-6 in their culture supernatants compared with NT-BSP-treated macrophage/CD4+ T cell co-cultures (Figure S4A). The results of real-time PCR showed that CD4<sup>+</sup>Th17<sup>+</sup> cells co-cultured with ET-BSP-treated macrophages contained higher levels of IL-17A, IFN-γ, IL-6, and the T cell homing markers CCR6 and CCR9 than did CD4<sup>+</sup>Th17<sup>+</sup> cells cocultured with NT-BSP-treated macrophages, but lower levels of IL-10 and IL-4 (Figure S4B). Next, we treated mice with ET-BSPs or NT-BSPs by daily colonic sub-mucosal injection for ten days. After this period, we observed extensive accumulation of CD4<sup>+</sup>IL-17A<sup>+</sup> cells and F4/80<sup>+</sup> macrophages in the colon (Figure S4C). To determine the molecular basis of this ET-BSP-mediated production of Th17 cells, the mice were treated by colonic submucosal injection of bacterial secreted particles from NTBFs genetically engineered to produce B. fragilis toxin (yETBF)<sup>11</sup>. Injection of BSPs from yETBF led to the detection of a higher percentage of Th17 cells at the injection sites when compared with mice that received wild-type NT-BSPs from WT-NTBF (Figure S4D, top panel). Furthermore, treatment with BSPs from NTBFs expressing a mutation of the B. fragilis toxin gene (BFT)<sup>11</sup> did not lead to an increase in Th17 cells. Collectively, these results suggest that the B. fragilis toxin gene plays a role in the ET-BSP-mediated proliferation of Th17 cells. Using a similar approach, we also showed that polysaccharide A (PSA) from wild-type NT-BSP bacteria 14 plays a role in the NT-BSP-mediated induction of Foxp3 (Figure S4D, middle panel). Innate lymphoid cells (ILCs) also contribute to gut homeostasis. No significant difference was detected in the accumulation of IL-22<sup>+</sup> ILCs in the colons of naïve mice injected with BSPs from YETBF when compared with naïve mice injected with BSPs from BFT (Figure S4D, the bottom panel), suggesting that the B. fragilis toxin protein preferentially regulates the induction of inflammatory cells.

To further determine the biological effects of ET-BSPs on epithelial cells, we examined gene expression in MC38 colon cells incubated with either NT-BSPs or ET-BSPs. Real-time PCR analysis showed that CCL20, CCL4, CXCL9, and COX2 were induced in MC38 cells stimulated with ET-BSPs but not NT-BSPs (Figure S5). The expression of SphK1 was elevated significantly in MC38 cells treated with ET-BSPs compared to those treated with NT-BSPs (Figure 2A). SphK1 is an enzyme that catalyzes the synthesis of S1P. The S1P has been implicated in the induction of several inflammatory mediators, including PGE2. We next investigated the effect of S1P on the production of PGE2 in primary cultured intestinal epithelial cells. As shown in Figure 2B, S1P promotes the expression of numerous chemokine genes as well as COX2, SphK1 and Sphk2. In addition, the induction of COX2 was consistent with the increase in PGE2 after S1P stimulation. As ET-BSPs can also be taken up by intestinal macrophages, MC38 cells were incubated with the supernatant from colonic macrophages stimulated with ET-BSPs or NT-BSPs. SphK1, SphK2 and COX2 were induced in MC38 cells treated with conditioned medium (CM) from ET-BSPstimulated macrophages (ET-BSP-CM), but not from NT-BSP-stimulated macrophages (NT-BSP-CM) (Figure 2C). Together, our data suggest that ET-BSPs induce the expression of Sphk1 and PGE2 in intestinal epithelial cells.

#### The uptake of ET-BSPs leads to an overproduction of exosomal S1P

Based on the results presented above, we hypothesized that intestinal bacteria regulate IDEN composition and subsequently have an effect on the induction of Th17 cells by ET-BSPs. An analysis of exosomes (IDENs that are isolated and purified from the supernatant of a cultured cell line such as MC38) derived from MC38 cells stimulated with ET-BSP-CM showed high levels of SPH, which is a substrate of Sphk1 used in the synthesis of S1P (Figure 3A) and CCL20 (Figure 3B). CCL20 is a ligand for the recruitment of CCR6<sup>+</sup> Th17 cells. We investigated whether S1P is induced after ET-BSP stimulation and leads to enrichment of S1P in exosomes. Exosomes were sucrose-purified from the supernatants of MC38 cells co-cultured for 48 h with ET-BSPs or NT-BSPs (named ET-Tumor EXO and NT-Tumor<sup>EXO</sup>, respectively); BSA served as a control (BSA-Tumor<sup>EXO</sup>). ET-Tumor<sup>EXO</sup> contained higher levels of PGE2 and S1P than NT-Tumor<sup>EXO</sup> or BSA-Tumor<sup>EXO</sup> (Figure 3C). Ceramide is involved in exosome biogenesis<sup>15</sup> and can be metabolized by ceramidase to sphingosine (SPH), which can be metabolized in turn to S1P by sphingosine kinase (SphK1). To determine whether SphK1 is involved in the induction of exosomal S1P, MC38 cells were treated with an SphK1 inhibitor (SK1-I) in the presence of ET-BSPs. As expected, the levels of S1P in ET-Tumor<sup>EXO</sup> decreased significantly after SK1-I treatment (Figure 3C). Interestingly, exosomal PGE2 (Figure 3C) and CCL20 (Figure 3D) were also downregulated by SKI-1. Collectively, these data suggest that ET-BSPs induce exosomal S1P, which further enhances the production of CCL20<sup>+</sup>PGE2<sup>+</sup>S1P<sup>+</sup> exosomes.

# ET-Tumor<sup>EXO</sup> S1P-activated Stat3 promotes tumor growth

To explore whether ET-Tumor  $^{EXO}$  could contribute to the promotion of colon cancer, we implanted MC38 tumors with ET-Tumor  $^{EXO}$  or NT-Tumor  $^{EXO}$  by orthotropic colonic submucosal microinjection. Co-injection of ET-Tumor  $^{EXO}$  dramatically promoted MC38 tumor growth compared with NT-Tumor  $^{EXO}$  (Figures 4A–4C), which further prompted us to analyze whether S1P+-enriched ET-Tumor  $^{EXO}$  could participate in promoting the

progression of colon cancer via the induction of CD4<sup>+</sup>Th17<sup>+</sup>. FACS analysis indicated that there were significantly more CD4<sup>+</sup>IL-17A<sup>+</sup> cells in the tumors harvested from mice treated with ET-Tumor<sup>EXO</sup> than those treated with NT-Tumor<sup>EXO</sup> (Figure 4D). By contrast, mice treated with NT-Tumor<sup>EXO</sup> had a high percentage of FoxP3<sup>+</sup> Tregs (Figure 4D). The quantity of IL-17A-producing CD8<sup>+</sup> cells was also increased 2- to 3-fold in tumors from ET-Tumor<sup>EXO</sup>-treated mice compared with NT-Tumor<sup>EXO</sup>-treated mice (Figure S6A). Real-time PCR results confirmed that IL-17A and CCR6 mRNA, but not IL-10 mRNA, were increased in tumors from ET-Tumor<sup>EXO</sup>-treated mice compared with NT-Tumor<sup>EXO</sup>-treated mice (Figure 4E). Furthermore, higher percentages of TNFα-producing CD4<sup>+</sup> T cells and IFN-γ-producing Th1 cells were observed in the ET-Tumor<sup>EXO</sup>-treated mice (Figure S6B).

A recent study suggests that sphingosine kinase-1 (SphK1), which is highly elevated in tumors, is regulated by S1PR1-STAT3 signaling <sup>16</sup>. We therefore investigated whether blocking SIP production had similar effects as ET-Tumor <sup>EXO</sup> on the induction of IL-17A and IL-6 by treating exosome-producing cells with SK1-I. SK1-I-ET-Tumor <sup>EXO</sup> or ET-Tumor <sup>EXO</sup> was added to cultures of OT-II CD4 T cells in the presence of OVA peptide and colonic macrophages. Analysis of the culture supernatants showed a reduction in inflammatory cytokines, particularly IL-6 and IL-17A (Figure S7), in the cells treated with SK1-I-ET-Tumor <sup>EXO</sup> in comparison with ET-Tumor <sup>EXO</sup>.

Previously published data suggest that the S1P-mediated pathway might activate Stat3<sup>16,17</sup> and that many different cells express S1P receptors. We found that naïve mice treated with ET-Tumor<sup>EXO</sup> had an extensive accumulation of CD11b<sup>+</sup> myeloid cells in their intestinal tissue and widespread Stat3 activation and S1PR1 expression on myeloid cells (Figures 4F–4G). Furthermore, SK1-I-ET-Tumor<sup>EXO</sup> was markedly less effective than ET-Tumor<sup>EXO</sup> in promoting MC38 tumor growth (Figure 4H), as evidenced by a decrease in proliferating epithelial cells, i.e., Ki-67<sup>+</sup> cells (Figure S8). Importantly, the phosphorylation of Stat3 was significantly decreased in the epithelium after SK1-I-ET-Tumor<sup>EXO</sup> treatment (Figure 4I). The role of S1PR1-STAT3 signaling was supported by a significant decrease in STAT3 phosphorylation after treatment with W146, a competitive S1PR1 antagonist (Figure 4J). We also found that W146 significantly decreased IL-17A and IL-6 secretion in LPLs treated with ET-Tumor<sup>EXO</sup> (Figure 4K). The results from an in vivo study also support the idea that W146 suppresses ET-Tumor<sup>EXO</sup>-induced tumor growth, the reduction in colonic CD4<sup>+</sup>IL-17A<sup>+</sup> cells, and the expression of COX2 in MC38 tumor–bearing mice (Figure 4L–3N).

## CCR6+CD4+Th17+ cells induced by APC-IDENs promote tumor growth

A challenging question in exosome biology is whether the biological effects of cell culture–derived exosomes can mimic those of endogenous exosomes isolated in vivo. APC<sup>Min/+</sup> mice were used to address whether exosomes isolated from the intestinal mucosa of mice under physiological and pathophysiological conditions play similar roles to exosomes from the MC38 cell line. APC<sup>Min/+</sup> is a point mutation in the murine homolog of the APC gene<sup>18</sup>. APC<sup>Min/+</sup> mice develop multiple intestinal adenomas, as do humans carrying germ-line mutations in APC. Our previously published data indicated that numerous IDEN particles accumulate in the intestinal mucosa and help to regulate gut immune function<sup>4,5</sup>. In the

present study, an increase in S1P was confirmed in the circulating exosomes and IDENs of APC<sup>Min/+</sup>, CAC and DSS mice (Figure S9A). Sphingosine was also elevated in the circulating exosomes and IDENs of APC<sup>Min/+</sup> and APC<sup>Min/+</sup> IDEN mice when compared with WT mice (Figure S9B).

To investigate whether APC-IDENs play a role similar to that of MC38 tumor exosomes in terms of tumor progression, APCMin/+ female mice were gavaged with APC-IDENs or WT-IDENs as a control twice a week for 8 weeks. Treatment with APC-IDENs (Figure 5A) resulted in increased tumor incidence and size compared with WT-IDEN treatment. The results in the mouse APC<sup>min/+</sup> tumor model were repeated in an azoxymethane/DSS (AOM/ DSS) tumor model (Figure S10). Histological examination of the small intestine showed a marked enhancement of the proliferation of IECs after APC-IDEN treatment, as measured by BrdU incorporation (Figure 5B). The phosphorylation of epithelial STAT3 and ERK1/2, both of which have roles in promoting colon cancer progression, was also found to be increased after APC-IDEN treatment (Figure 5C). FACS analysis showed that the quantity of CCR6<sup>+</sup>CD4<sup>+</sup>T cells was significantly increased in the tumors of mice treated with APC-IDENs (Figure S11A) or CAC-IDENs (Figure S11B) in comparison with WT-IDENs. Furthermore, FACS analysis identified a higher percentage of intestinal CCR6<sup>+</sup>CD4<sup>+</sup>Th17<sup>+</sup> cells in mice treated with APC-IDENs compared with those treated with WT-IDENs (Figure 5D). Real-time PCR analysis showed that expression of IL-17A and IL-6 was higher in colonic CD4<sup>+</sup> T cells from mice treated with APC-IDENs compared with WT-IDENs (Figure 5D). To assess whether the increase in IL-17A contributed to tumorigenesis, IL-17A was neutralized with an IP injection of anti-mouse IL-17A antibodies in APC-IDEN-treated APCMin/+ mice. The results, including colonic inflammation, proliferation of epithelial cells and tumor numbers (Figure 5E-G), suggest that the neutralization of IL-17A eliminates the tumorigenic effects of APC-IDENs.

## APC-IDENs induce CCR6+CD4+Th17+ cell homing to the gut

Our data showed that (1) double PKH26<sup>+</sup>F4/80<sup>+</sup> fluorescence increased in the lamina propria of the large intestines of APC<sup>Min/+</sup> mice (Figure 6A); (2) PKH26-labelled IDENs were also evident in the tumors of APC<sup>Min/+</sup> mice (Figure 6B); and (3) macrophages from small intestinal lamina propria (SI-LP) captured PKH26-labeled IDENs bound to GFP-bacteria and the captured IDENs were present in macrophages<sup>F4/80+</sup> (Figure 6C, left panel). In comparison with WT-IDENs, colonic macrophages that were cultured in the presence of APC-IDENs and intestinal bacterial lysates secreted higher levels of CCL20 (Figure 6D). APC-IDENs also increased the production of IL-23, IL-6 and TNF-α. Thus, the uptake of APC-IDENs by macrophages (macrophages<sup>APC-IDEN+</sup>) leads to the induction of CCL20, which is a specific ligand for recruiting CCR6<sup>+</sup>CD4<sup>+</sup>Th17<sup>+</sup> cells. Western blot analysis indicates that the levels of CCL20 are much higher in IDENs from APC<sup>min/+</sup> and CAC mice than in those from WT mice (Figure 6E). Collectively, macrophages<sup>APC-IDEN+</sup> and APC-IDENs provide a CCL20-enriched source for the possible recruitment of CCR6<sup>+</sup>CD4<sup>+</sup>Th17<sup>+</sup> T-cells into the intestine.

The induction of CCR6 expression on naïve CD4 T cells is required to achieve preferential recruitment of Th17 cells to the gut<sup>1</sup>. FACS analysis indicated that a greater number of

PKH26-labeled IDENs were circulating in the peripheral blood of APCMin/+ diseased mice than of naïve mice after IDENs were given orally (Figure 6F), suggesting that a higher quantity of IDENs are in circulation in the peripheral blood under pathophysiological conditions than under normal conditions. MUC2 is fundamental for maintaining the integrity of the intestinal barrier<sup>19</sup>, and CD3-specific antibody treatment induces intestinal inflammation, increases gut permeability<sup>20</sup>, and promotes Th17 cell recruitment to the intestine<sup>1</sup>. Our FACS data indicate that higher levels of IDENs were in circulation in the peripheral blood of anti-CD3-treated mice than in that of naïve control mice (Figure 6F). This result was also consistent with the immunostaining of intestinal MUC2, indicating that mice that were pretreated with anti-CD3 antibodies exhibited a considerably lower level of intestinal MUC2 staining than those pretreated with a control IgG (Figure S12A). Next, we tested whether APC-IDEN treatment leads to an increase in molecules that encourage recruitment of Th17 cells to the gut such as CCR6, CCR4, CCR9, IL-6 and IL-17A. Our FACS analysis data indicate that CCR6, CCR4 and CCR9 expression on cultured T cells treated with APC-IDENs was much higher than on those treated with WT-IDENs (Figure 6G). The supernatants from cultured T cells treated with APC-IDENs contained higher levels of inflammatory molecules, i.e., IL-6 and IL-17A, than supernatants from WT-IDEN treated cells (Figure 6H). In accordance with the enhanced expression of these molecules, APC-IDEN treatment induced a stronger chemotactic activity in CD4<sup>+</sup> T cells (Figure 6I), partly through an increase in CCR6, which was demonstrated in CD4<sup>+</sup> T cells from CCR6 KO mice (Figure 6I, right panel). APC-IDEN treatment leading to the enhanced expression of these molecules was also demonstrated in a co-culture of T cell-OVA pulsed macrophages (Figure S12B). The roles of APC-IDENs were further demonstrated with recruitment experiments in vivo. Equivalent numbers of PKH26-labeled naive CD4+ T cells were pre-treated with WT-IDENs or APC-IDENs and adoptively transferred into recipients with DSS-induced colitis. CD4<sup>+</sup> T cells treated with APC-IDENs induced greater migration of CD4+ cells from the blood into the inflamed colons of DSS-treated SCID mice than did CD4<sup>+</sup> T cells treated with WT-IDENs (Figure 6J). Furthermore, RAG1<sup>-/-</sup> mice that received adoptively transferred CD4+CD25-CD62Lhi naïve T cells and were subsequently gavaged with APC-IDENs developed rapid and very severe colitis 7 weeks after the cell transfer whereas mice who were gavaged with WT-IDENs did not. The exacerbation of colitis in the mice that received APC-IDENs was evidenced by greater weight loss, an accumulation of CD4<sup>+</sup>Th17<sup>+</sup>T cells and severe damage to epithelial cells, as indicated by severe dysplastic changes in the colon (Figure S13A-13D). Together, these data suggest that APC-IDENs have a direct effect on increasing the susceptibility of mice to colitis and carcinogenesis through the induction of inflammatory CCR6+CD4+Th17+ cell circulation and subsequent recruitment to the gut.

## APC-IDEN PGE2 plays a role in the accumulation of Th17 cells

Our previously published data<sup>4,21</sup> suggest that exosomal PGE2 plays a role in immunomodulation. PGE2 is known to enhance the proliferation of CCR6<sup>+</sup>Th17<sup>+</sup> cells and the expression of CCL20<sup>22</sup>. ELISA analysis indicated that the level of PGE2 was much higher in the IDENs from APC<sup>min/+</sup> and CAC mice than from those from naïve WT mice (Figure 7A). The induction of IDEN PGE2 was not only demonstrated in the tumor models we tested but also in an anti-CD3 induced inflammation mouse model. Anti-CD3 treatment

significantly increased COX2 expression in WT mice, and increased levels of PGE2 were detected in their IDENs (Figure 7B). To confirm that PGE2/COX2 signaling was involved in Th17 accumulation in the intestine, mice treated with the COX2 inhibitors indomethacin and celecoxib during anti-CD3 treatment showed a noticeable decrease in accumulation of CD4<sup>+</sup>IL-17A<sup>+</sup> cells (Figure 7C and Figure S14A) and liquid stool (Figure S14B) in the small intestine. A recent study showed that Th17 cell expansion induced by PGE2 is mediated by EP4<sup>23</sup>. Consistent with these results, naïve T cells were activated when they were cultured with APC-IDENs, and there was a significant increase in IL-17A production in cells cultured with APC-IDENs when compared with WT-IDENs (Figure 7D). AH6809 (an EP2-selective antagonist) and ONO-AE3-208 (an EP4-selective antagonist) partially reversed APC-IDEN PGE2-induced IL-17A production (Figure 7D).

## MyD88 regulates APC-IDEN recruitment and the activation of Th17

Previous studies<sup>24</sup> have suggested that the physical separation of microbiota from the intestinal surface is a restriction factor for immune activation, and perturbed spatial relationships between intestinal bacteria and hosts correlate with disease states such as inflammatory bowel disease (IBD). Our EM imaging data indicate that numerous tiny microvesicles observed in the intestinal lumen (Figure 8A, left panel) reside in the same compartment as intestinal bacteria (Figure 8A, right panel). Interestingly, CD63+, an exosomal marker, was co-localized with 16S rRNA<sup>+</sup> in the outer mucosa layer (Figure 8B). Confocal analysis showed a remarkable increase in the number of CD63<sup>+</sup> IDENs that colocalized with 16S rRNA<sup>+</sup> bacteria in the colonic mucosa of APC<sup>min/+</sup> mice compared with their co-housed wild-type littermates (Figure 8B). CD63<sup>+</sup> exosome/bacterial rRNA16 was also evident in isolated lymphoid follicles in APCMin/+ mice (Figure 8C). In comparison with WT mice, APCMin/+ mice had greater quantities of CD63<sup>+</sup> not only in the epithelial lumen (Figure 8D, top panels) but also in the lumen of the crypts (Figure 8D, bottom panels) and tumor tissue (Figure 8E). Collectively, these data suggest that CD63<sup>+</sup> IDENs co-localize with intestinal bacterial 16S rRNA<sup>+</sup>, and the depletion of the APC gene enhanced this colocalization and the number of CD63<sup>+</sup> IDENs.

Next, we assessed the effects of intestinal bacteria on the IDEN-mediated induction of CD4+Th17+ T cells. Oral transfer of IDENs from untreated APC<sup>Min/+</sup> mice resulted in increased tumor size and number and percentage of IL17A-producing CD4+ T cells in the lamina propria of antibiotic-pretreated APC<sup>Min/+</sup> mice. By contrast, untreated mice gavaged with IDENs from antibiotic-treated APC<sup>Min/+</sup> mice failed to show an increase in the number or size of tumors, Th17 gene expression (Figures S15A–15C), or the expression of pSTAT3 and pERK (Figure S15D). Collectively, these data suggest that endogenous gut bacteria regulate the IDEN-mediated induction of Th17 cells and tumor growth. We then tested whether the activation of a TLR-MyD88 pathway affects the APC-IDEN-mediated induction of CCR6+CD4+Th17+ cells. In comparison with WT mice, MyD88 knockout led to a reduction in circulating PKH26+IDEN+ cells (Figure 8F) and stronger intestinal Muc2 staining (Figure 8G) in mice pretreated with anti-CD3 antibodies. FACS analysis further showed that IDENs from APC<sup>Min/+</sup> /MyD88-/- mice (APC/MyD88-IDEN) failed to induce the expression of chemokine receptors, particularly CCR6 and CCR4, on CD4+ T cells (Figure 8H). The proinflammatory cytokines IL-17A and IL-6 were also decreased

significantly in response to APC/MyD88-IDEN stimulation (Figure 8I). Collectively, these data suggest that the MyD88-mediated pathway plays a role in increasing the quantity of circulating IDENs, and a higher number of circulating APC-IDENs leads to greater induction of CCR6+CD4+Th17+ cells. This conclusion is supported by the fact that CD3-specific antibody treatment failed to induce the accumulation of Th17 cells, diarrhea or liquid stools in the small intestines of MyD88-/- or APCmin/+MyD88-/- mice (Figures S16A and S16B). IDENs from MyD88-/- mice pretreated with anti-CD3 treatment have much lower concentrations of COX2/PGE2 and CCL20 (Figure 8J). Oral transfer of IDENs from MyD88-/-APCmin/+ mice fails to increase tumor number and size, recruitment of Th17 cells or the expression of pSTAT3 and pERK (Figures S15A-15D). In summary, these data suggest that the MyD88-mediated pathway plays a role in the APC-IDEN-mediated recruitment and activation of CCR6+CD4+Th17+ cells.

#### **Discussion**

The balance of Th17 and regulatory T cells in the gut is essential for maintaining gut homeostasis and preventing colon cancer and colon inflammatory-related diseases<sup>25</sup>. The results presented in this study suggest that a hierarchy of IDEN factors, each of which encompasses a distinct set of mechanisms, plays a role in the intestinal homeostasis of Th17 cells. First, IDEN<sup>CCL20+PGE2+</sup> is an intestinal immune mediator that, at minimum, plays a role in both the recruitment and proliferation of Th17 cells. In colon tumor-bearing hosts, IDENs are more potent in their recruitment and proliferation of Th17 cells because of S1Pmediated overproduction of IDENCCL20+PGE2+. Second, unlike NT-BSPs, which induce regulatory T cells, ET-BSPs induce Th17 cells through the S1P-mediated overproduction of IDEN<sup>CCL20+PGE2+</sup>. Finally, the induction of intestinal macrophage PGE2 by IDEN<sup>CCL20+PGE2+</sup> further drives the overproduction of CD4<sup>+</sup>CCR6<sup>+</sup>IL17A<sup>+</sup> cells in colon tumor-bearing hosts. Furthermore, we found that intestinal bacterial genes encoding the B. fragilis toxin and PSA play a role in mediation of the balance of Th17 and regulatory T cells in the gut by BSPs. The significance of this finding lies in the well-known regulation of the balance of T reg/Th17 cells by gut bacteria. Whether gut bacteria-derived products such as BSPs participate in the modulation of this counterbalance has not been previously addressed; furthermore, if they do indeed participate, the molecular mechanism(s) underlying the counterbalance have yet to be defined. Our data suggest that bacteria are not required to be co-localized with host cells and bacteria-derived BSPs to direct and regulate this counterbalance. Unlike gut bacteria, BSPs can act over a long distance without causing infection, allowing bacteria to communicate with the host immune system by releasing BSPs. Another feature of BSPs is that they may provide a means for bacterial proteins and lipids such as sphingolipids<sup>26</sup> to be transported as a complex with other bacterial factors while being protected from degradation. Bacterial-derived factors such as S1P may also play a role in gut immunomodulation in collaboration with IDENs.

Finally, S1P may contribute to the overproduction of IDEN<sup>CCL20+PGE2+S1P</sup>. S1P is known to promote tumor progression, and tumor cells produce much higher levels of S1P<sup>27</sup> than non-tumor cells. In this study, our data indicate that ET-BSPs are taken up by colon epithelial tumor cells, which leads to activation of the SphK1-mediated production of S1P.

Our pharmacological inhibitor data suggest that S1P may promote the production of IDEN<sup>CCL20+PGE2+S1P</sup>.

Numerous studies suggest that many different types of tumor cells secrete S1P and that S1P plays an important role in cancer progression<sup>27</sup>. The majority of the biological effects of S1P are known to be mediated via the activation of five specific G protein-coupled receptors (S1PR1-5) located on the cell surface<sup>28</sup>. Secreted S1P produced inside cells by sphingosine kinases can then signal through these receptors in an autocrine, paracrine, and/or endocrine manner, which is termed the 'inside-out signaling' of S1P. A major current topic in S1P biology is how S1P is released from S1P producer cells. Because S1P possesses a polar head group, the S1P that is generated inside the cells cannot freely pass through the cell plasma membrane. Our study indicates that exosomes can be used as an S1P delivery vehicle for intercellular communication. In addition to the fact that intestinal exosome S1P regulates Th17 activity, other immune cells such as innate lymphoid cells also play a critical role in gut homeostasis<sup>29–32</sup>. Our findings will open up new avenues for determining whether intestinal exosome S1P regulates other immune cells, such as innate lymphoid cells, in gut homeostasis.

It is conceivable that the transient induction of IDEN<sup>CCL20+PGE2+S1P+</sup> is beneficial for cleaning up infectious agents, whereas the persistent release of IDEN<sup>CCL20+PGE2+S1P+</sup> may cause chronic inflammation that generally promotes tumor progression<sup>9,33</sup>. IDEN-producing cells, i.e., mouse intestinal epithelial cells, which are renewed every 4–5 days, have a limited lifespan and are likely to be crucial for gut homeostasis<sup>34</sup>. Intestinal epithelial cells exposed to pathogenic secreted particles (SPs) can induce appropriate mucosal immune responses, but the survival of intestinal epithelial cells containing pathogenic SPs is limited. Therefore, the pathogenic SP-mediated induction of IDEN<sup>CCL20+PGE2+S1P</sup> is terminated as a result of intestinal epithelial self-renewal. However, if IDEN-producing cells are transformed into colon tumor cells, the transformed cells could continuously release IDENs with higher levels of CCL20<sup>+</sup>PGE2<sup>+</sup>S1P<sup>+</sup>, which could drive the recruitment and induction of Th17 cells. Because many different types of tumor cells have been reported to release high levels of S1P<sup>27,35</sup>, it is conceivable that these tumor cells could release CCL20<sup>+</sup>PGE2<sup>+</sup>S1P<sup>+</sup> exosomes and mediate both the induction and recruitment of Th17 cells without ET-BSPs.

The findings in our mouse model studies are directly translatable to human colon cancer. S1P and PGE2 levels are unregulated in human colon cancer patients<sup>36</sup>. S1P and PGE2 may therefore be promising targets for effective specific therapies. Because the free forms of S1P and PGE2 are unstable, one potential strategy would be to develop a method to accelerate S1P degradation by preventing S1P and PGE2 from associating with intestinal exosomes.

Based on this study, we also speculate that two subsets of commensal bacteria SPs may coexist in the gut: one that induces Th17 cells and one that induces regulatory T cells. It has been reported that the phagocytosis of apoptotic cells in the absence of microbial signals induces the differentiation of regulatory T cells, whereas the phagocytosis of infected apoptotic cells induces Th17 cell differentiation<sup>37</sup>. Interestingly, the immunosuppressive nature of infected cell clearance coexists with the inflammatory nature of infection<sup>37</sup>. Commensal bacteria SPs are probably passing constantly through the lumen and being taken

up by intestinal epithelial cells to release tolerogenic IDENs to induce regulatory T cells. Th17 cells predominantly recruit to the gut, and both Th17 cells and regulatory T cells are required for maintaining gut homeostasis, but whether there is also a subset of non-pathogenic SPs that regulate the immunogenic IDEN-mediated induction of Th17 remains unknown. Therefore, our findings warrant further research to determine whether two subsets of SPs are released from commensal bacteria: one regulating the tolerogenic IDEN-mediated production of regulatory T cells and one regulating immunogenic IDEN-mediated Th17 cell production. Dysregulation of this balance may lead to diseases such as colon cancer.

Our data suggest that WT-IDENs may suppress CCL20 and other proinflammatory cytokines that are expressed in bacterial lysate-stimulated macrophages. Data published by other research groups  $^{26}$  suggest that Bacteroides produce  $\alpha$ -galactosylceramide, which regulates NKT activity. Our previously published data  $^{4,5}$  also suggest that WT-IDENs suppress liver NKT cell activation. We have not addressed in this study whether intestinal bacterial-derived factors incorporated into IDENs play a role in IDEN-mediated intestinal Th17 homeostasis, but we have provided a foundation for the future study of this topic.

# **Experimental procedures**

#### **Animals and Treatments**

C57BL/6J, Rag1<sup>-/-</sup>, CCR6<sup>-/-</sup>, OT-II and APC<sup>Min/+</sup> mice on C57BL/6 background were obtained from Jackson Laboratories. Myd88<sup>-/-</sup> mice on C57BL/6 background were kindly provided by S. Akira (Osaka Univ., Osaka, Japan), and were crossed to APC<sup>Min/+</sup> mice. All animal procedures were approved by the University of Louisville Institutional Animal Care and Use Committee.

## Mouse models of colon cancer

(1) APCMin/+ mice carrying a mutation in Apc gene that mimics familial adenomatous polyposis and the majority of sporadic colon cancers and (2) Colitis associated colon cancer (CAC) models were induced by azoxymethane (AOM) treatment followed by dextran sodium sulfate (DSS). AOM was injected intraperitoneally into 6- to 8-week-old male mice at 15 mg/kg. One week after the injection, the mice were exposed to 3 cycles of 1 week of 2.5% DSS (molecular weight 36,000-50,000; MP Biomedicals) in the drinking water followed by 2 weeks of normal water regimen. Colitis was induced using a 2.5% solution of DSS that was provided as drinking water to mice (18–25 g, 6 weeks old, male) for 10–12 days. (3) In the third model, mice had an orthotopic colonic sub-mucosal implantation of colon cancer cells. 7-week-old female mice were anesthetized using Ketamine/Xylazine and sub-mucosal injections were accomplished using a murine colonoscopy system, which consisted of a miniature endoscope, a xenon light source, a triple chip camera, and an air pump (Karl Storz, Tuttlingen, Germany). Briefly,  $10 \mu l (1 \times 10^5)$  of MC38 tumor cells with or without ectopic luciferase expression were inserted through a Luer lock (Söllner, GmbH) stainless needle screwed on the working channel of the scope. The scope was then inserted into the mouse colon and the needle was brought through the working channel to the scope's front. The injection was performed by a very gentle sub-mucosal penetration with the open side of the bevel heading up at a flat angle.

## Isolation and purification of IDENs

Mice were euthanized and the intestine removed. The luminal contents of the intestine were removed by gently flushing the intestine with 10 ml of ice-cold PBS. The intestine was then opened longitudinally, the mucus collected by mild physical separation using round forceps, soaked in PBS, then agitated on a rotator at 70 rpm/min for 15 min and centrifuged at  $500 \times g$  for 15 minutes at 4°C. The supernatant was then followed by differential centrifugation and sucrose gradient centrifugation to isolate and purify the exosomes using a previously described protocol<sup>38</sup>. Protein concentration was determined using the Bio-Rad Protein Quantitation Assay kit with bovine serum albumin as a standard. Each lot of IDENs used for this study was also FACS analyzed for CD63, an exosomal marker, and A33, a marker of intestinal epithelial cells. Exosomes used in this study were always more than 90% of CD63+ A33+IDENs.

## Adoptive transfer of IDENs or exosomes

Adoptive transfer of various IDENs (250 $\mu$ g in PBS) was performed once every three days for eight weeks by oral administration in APCMin/+ mice at six weeks of age with/without antibiotic treatment. IDENs (APC-IDENs) were isolated from APCMin/+ mice at 4 months of age. IDENs (CAC-IDENs) (250 $\mu$ g) were isolated from CAC mice 3–4 months after AOM plus DSS administration. CAC-IDENs were intra-rectally transferred into AOM-treated mice after the first DSS cycle. IDENs were delivered through a 1.2-mm-diameter polyurethane catheter (Access Technologies) for eight weeks. Mice were euthanized at 3 months of age and polyps were counted using a stereomicroscope. Tumor exosomes (250  $\mu$ g) derived from MC38 cells treated by ET-BSP or NT-BSP were transferred into tumor bearing mice or naïve mice by colonic submucosal injection every two days for 18 days. Colon sections were fixed in formalin or snap frozen. In some experiments, polyps were harvested individually and frozen in liquid nitrogen.

#### Antibiotic or antibody treatment

Mice were given the following antibiotics in autoclaved drinking water: ampicillin (1g/l; Sigma), vancomycin (500 mg/l; Henry Schein, Inc.) neomycin sulfate (1g/l; Sigma), and metronidazole (1g/l; Sigma; solubilized with 15 ml of 0.1N acetic acid/liter). Fresh antibiotics were supplied every three days. Mice were kept on antibiotics for the indicated time and killed for tumor and tissue analysis. Mice were administered IDENs resuspended in PBS by gavage or intravenous injection as described previously<sup>39</sup>. In some experiments, neutralizing antibody (200 μg/mouse) for IL-17A (MAB421 R&D Systems) or control IgG was injected once every week for eight weeks. ApcMin/+ and ApcMin/+/MyD88<sup>-/-</sup> littermates were euthanized at 3–4 months of age or when the first signs of morbidity appeared. The intestinal tract was removed immediately after euthanasia. The small intestine and colon were examined, and tumors were counted and measured using a stereomicroscope. Most polyps were adenomas, identified by their appearance as grossly visible, preinvasive lesions that were common in the small intestine of APC<sup>Min/+</sup> mice. Colonic lesions that displayed a focally invasive phenotype were categorized as tumors. Five-μm sections of paraffinembedded specimens were cut and stained with H&E for histology analyses.

#### Induction of colitis

T cell mediated colitis was induced in  $Rag1^{-/-}$  mice by adoptively transferring CD4<sup>+</sup>CD25<sup>-</sup>CD62L<sup>+</sup> T cells sorted using a FACSAria II flow cytometer (BD Biosciences). The  $Rag1^{-/-}$  recipients were given  $5\times10^5$  CD4<sup>+</sup>CD25<sup>-</sup>CD62L<sup>+</sup> T cells via intraperitoneal injection, and were euthanized at 6–7 weeks after transfer. For the adoptive transfer of IDEN experiment, some recipient mice also received by oral administration 250µg of WT-IDENs or APC-IDENs once every three days for 6 weeks after the transfer of CD4<sup>+</sup>CD25<sup>-</sup>CD62L<sup>+</sup> T cells.

Colitis was also induced in C57BL/6J mice by the addition of 2.5 % (wt/vol) DSS (36–50KD molecular weight, MP Biomedicals, OH) in their drinking water. Beginning at day – 10 of DSS treatment, mice were orally treated with PBS, NT-BSP (200  $\mu$ g) or ET-BSP (200  $\mu$ g) every other day for 20 days. DSS solution was freshly prepared every other day. Body weight and physical activity were monitored daily.

## Flow cytometry

For analysis of surface markers, cells were stained in PBS containing 2% (wt/vol) BSA. Intracellular staining of the transcription factors Foxp3 was performed using the Foxp3 Fix/ Perm Buffer Set (Biolegend). For detection of intracellular cytokines, cells were first stimulated for 4 h with 50ng/ml PMA and 1 µg/ml ionomycin in the presence of Brefeldin A (All obtained from Sigma), followed by staining for surface markers. Cells were then fixed and permeabilized using the Foxp3 Fix/Perm Buffer Set (Biolegend) and stained for intracellular cytokines. The following antibodies were used at a dilution of 1/200–1/600: PerCP-Cy5.5, PE-, FITC- or APC-labeled anti-IL-17 (TC11-18H10.1), PE- or APC-labeled anti-IL-10 (JES5-16E3), PE-labeled anti-Foxp3 (FJK-16s, eBioscience), PE-, FITC- or APC-labeled anti-CCR6 (29-2L17), PE-, FITC- or APC-labeled anti-CD4 (RM4-5), PE-Cy7-labeled anti-CD3 (145-2C11), APC- or PE-Cy7-labeled anti-IFN (XMG1.2), FITC-, PerCP-Cy5.5 or Pacific Blue-labeled anti-CD45 (30-F11), PE-anti-CCR4 (2G12), PE- or FITC-labeled anti-CCR9 (CW-1.2). All antibodies were obtained from Biolegend unless otherwise noted. Flow cytometry data were acquired on a 5-color FACScan (Becton Dickinson), and analyzed using FlowJo software (Treestar). Cell sorting was performed using a FACSAria II.

#### Histology and immunohistochemistry

Tissue specimens were fixed in 10% formalin, dehydrated, and then embedded in paraffin. Tissue samples were cut at 5  $\mu$ m thicknesses and stained with hematoxylin and eosin. For immunofluorescence analysis, tissue sections were subjected to antigen retrieval by boiling the slides in Antigen Unmasking Solution (Vector Laboratories) for 10 minutes according to instructions. Sections were then blocked for 1 hour at 22°C with 5% BSA in PBS and incubated overnight at 4°C with the primary antibodies (rabbit polyclonal Ki67, phospho-Stat3<sup>Tyr705</sup> and phospho-Erk antibody from Cell Signaling used at a dilution of 1/100, and rat polyclonal CD63, Muc2 from AbCam [Cambridge, MA], rabbit polyclonal CD63, Jam-a from Santa Cruz Biotechnology Inc [Santa Cruz, CA] used at a dilution of 1/50, CD11b and E-Cadherin were gained from BD Bioscience (San Jose, CA) and used at a dilution of 1/100. Primary antibodies were detected by Alexa Fluor 488, 594 or 647 conjugated goat anti–

mouse, anti–rabbit IgG and anti-rat (1:600, Invitrogen), respectively. Tissues were counterstained with DAPI and images were captured on a Zeiss LSM 510 confocal microscope equipped with a digital image analysis system (Pixera). For immunofluorescence analysis of macrophages, OCT (Sakura Finetek)-embedded tissue cryosections (9µm-thick) were stained by F4/80 (BM8, ebioscience).

## **Western Blot Analysis**

Exosomes or cells were disrupted in lysis buffer containing 1% Triton X-100, 0.1% SDS, 150 mM NaCl, 50 mM Tris-HCl, 1 mM EDTA, 1 mM EGTA, 5 mM sodium molybdate, and 20 mM phenylphosphate with protease and phosphatase inhibitors (1 mM PMSF, 10  $\mu$ g/mL aprotinin, 20  $\mu$ g/mL leupeptin, 20  $\mu$ g/mL pepstatin A, 50 mM NaF, and 1 mM sodium orthovanadate) for 30 min on ice. The samples were centrifuged (16,000  $\times$  g, 10 min, 4°C) and the resulting supernatants transferred to fresh tubes. Protein lysates were quantitated using a Bio-Rad protein kit (Bio-Rad) and 50  $\mu$ g of exosomal lysates were separated on 10% SDS polyacrylamide gels and transferred to a nitrocellulose membrane.. Rabbit anti-Stat3 (727), p-Stat3 (705), STAT3 and actin were purchased from Cell Signaling Technology (Danvers, MA) and used at a dilution of 1/1000. Anti-CCL20 was purchased from Biorbyt (San Francisco,CA) and used at a dilution of 1/1000. Membranes were probed with specific antibodies and protein quantity visualized using an Odyssey instrument (Li-CoR Bioscience). Images have been cropped for presentation. Full size images are presented in the supplemental material.

#### RNA extraction and PCR

Total RNA was isolated from the distal small intestine, lamina propria lymphocytes (LPL) or MA38 tumor cells using the Qiagen RNeasy RNA isolation Kit and was used to synthesize cDNA. RNA (1 $\mu$ g) was reverse-transcribed with Superscript III and random primers (Invitrogen). For quantitation of genes of interest, cDNA samples were amplified in a CFX96 Realtime System (Bio-Rad Laboratories, Hercules, CA, USA) and SYBR Green Master Mix (Invitrogen) and specific primers (Supplemental Table 1) according to the manufacturer's instructions. Fold changes in mRNA expression between treatments and controls were determined by the  $\delta$ CT method as described<sup>40</sup>. Differences between groups were determined using a two-sided Student's *t*-test and one-way ANOVA. Error bars on plots represent  $\pm$  SE, unless otherwise noted. The data were normalized to a GAPDH reference. All primers were purchased from Eurofins MWG Operon.

#### Fluorescence in situ hybridization (FISH)

Intestinal tissues were prepared for FISH analysis by fixation in Carnoy's fixative (Electron Microscopy Sciences, Hatfield, PA). Two 30-minute washes in dry methanol were followed by two 20-minute washes in absolute ethanol. Before paraffin embedding and sectioning, the fixed tissue was incubated twice in xylene for 15 minutes. Tissues were sectioned at a thickness of 5 µm and FISH analysis was performed using the EUB338 probe (GCTGCCTCCGTAGGAGT) labelled with Alexa488, against 16S rRNAs from most bacteria. The nonsense probe Non338 (ACTCCTACGGGAGGCAGC) was used to test for

nonspecific binding of oligonucleotide probes. Hybridizations were carried out and tissues were visualized using a Zeiss LSM 510 confocal microscope.

#### **Bacterial Strains and Growth Conditions**

Non-enterotoxigenic *Bacteroides fragilis* strain NCTC9343 and enterotoxigenic *Bacteroides fragilis* strain (20656-2-1) were obtained from the American Type Culture Collection. Nontoxigenic wild-type *B. fragilis* (WT-NTBF) overexpressing *BFT* (γETBF; *BFT-2*) and WT-NTBF overexpressing a biologically inactive mutated *BFT* ( BFT; *bft-2* H352Y) were kindly provided by Dr. Sears<sup>41</sup>. Wild-type NCTC9343 with mutant polysaccharide A (PSA) was kindly provided by Dr. Comstock<sup>42,43</sup>. *Bacteroides fragilis* were cultured either in brain heart infusion (BHI) broth (BD Biosciences) or in 1 L of basal PYG medium containing 5g glucose, 1% FBS, 0.5 mg hemin, and 0.5 mg/ml vitamin K, 0.5g L-cysteine, 5g potassium phosphate. Cultures were grown at 37°C under anaerobic conditions.

#### Pharmacological agents

IDEN lipids were extracted according to Bligh and Dyer<sup>44</sup> in chloroform/methanol/water (2.5:2.5:2.1, v/v/v). Lipids for treatment of cells were dried under nitrogen and sonicated in PBS at pH 7.4 and 0.05% (vol/vol) Tween-20 before use. PGE<sub>2</sub>, Butaprost, misoprostol, sulprostone and PGE<sub>2</sub> ELISA kits were obtained from Cayman Chemical. EP4 agonists (ONO-AE1-329), EP1 antagonist (ONO-8713), EP3 antagonist (ONO-AE3-240), and EP4 antagonist (ONO-AE3-208) were kind gifts from Ono Pharmaceutical Company. SK1-I and W146 were obtained from Sigma.

## **BSP Purification and Labeling**

BSP was isolated and purified from cultured bacteria. *B. fragilis* was grown in PYG media to early stationary phase. *B. fragilis* bacteria were removed by pelleting  $(2000 \times g, 20 \text{min}; 10,000 \times g, 1h)$ . BSP were then recovered from the bacteria-free culture supernatant by centrifugation  $(100,000 \times g, 1.5 \text{ h})$ , purified by sucrose gradient centrifugation using a previously described protocol<sup>38</sup>, and washed with PBS by centrifugation at  $100,000 \times g$  for 1 h. The pellet was resuspended in PBS, and stored at  $-80^{\circ}\text{C}$  until used. PKH26-labeled BSP were prepared as previously described<sup>4</sup>.

#### Isolation lamina propria lymphocytes (LPL) and flow cytometry analysis

The method used for isolation of LPL has been previously described<sup>45</sup>. In brief, fat tissues and PPs were removed from small intestine. The intestine was open and cut in pieces 1 cm long and incubated in an HBSS solution containing 5 mM EDTA and 10 mM Hepes) for 30 minutes at 37°C with slow rotation (180 rpm/minutes). Pieces were then further cut and incubated in an HBSS solution containing 0.5 mg/ml DNase I (Roche) and 1 mg/ml Collagenase type IV (Worthington). Finally, the solution containing digested tissue was passed through a 100 µm cell strainer and LPLs were recovered at the interface of the 40 and 80% Percoll (GE Healthcare) solutions. For flow cytometry analysis, the cells were labeled using standard procedures<sup>46</sup>. Cells were analyzed by flow cytometry using a FACScan (BD Biosciences protocol; BD Pharmingen). In some experiments, stained cells were sorted to

purify indicated populations on a BD FACS Aria III. Histogram analysis was performed using FlowJo software (Treestar, Ashland, OR).

#### **ELISA**

IL-6, IL-10 and IL-17 in culture supernatants were quantified using ELISA kits (eBioscience). For PGE2 assay: Lipids were extracted from exosomes and IDENs in 70% cold ethanol, 30% monobasic sodium phosphate (0.1 M), pH 4.0, followed by shaking incubation for 30 minutes at 24°C. Homogenates were centrifuged at 1,000×g for 10 minutes. Triplicate aliquots of supernatants were dried under nitrogen, and the PGE2 concentration was determined by ELISA (Cayman Chemical).

#### **Cell cultures**

For IDEN-mediated Th17 differentiation, naive T cells were cultured for 5 days with anti-CD3 (5µg/ml, 2C11, Bio × cell), anti-CD3, anti-CD28 (2µg/ml, 37.51; Bio × Cell), IL-6 (20 ng/ml), TGF-β1 (2 ng/ml; R&D Systems), anti-IL-4 (10μg/ml), anti-IFN-γ (10μg/ml) and IL-23 (20ng/ml) in the presence of IDENs (50µg/ml), followed by stimulation with PMA and ionomycin in the presence of GolgiStop. Intracellular cytokine production and chemokine receptor expression on CD4<sup>+</sup> T cells were then determined by flow cytometry. For colonic macrophages-T cell cocultures,  $5 \times 10^4$  macrophages and  $2.5 \times 10^5$  OT-II T cells were mixed in the presence of cognate peptide (5 µg/ml; OVA) and/or IDENs (50µg/ml). After 4 d of culture, live T cells were collected and stimulated with PMA (phorbol 12myristate 13-acetate, 50 ng/ml) and ionomycin (1µg/ml Sigma) plus brefeldin A (10µg/ml Sigma) for intracellular cytokine staining or for mRNA analysis. To study the activity of BSP on tumor cells, the colon cancer cell line MC38 was acquired from the American Type Culture Collection and cultured as recommended. MC38 cells were cultured with BSP (50µg/mL) in the absence or presence of 5 µM SK1-I for 48h, exosomes were prepared according to a previously described protocol<sup>47</sup>. In some experiments, MC38 cells were treated with S1P (100 nM), mRNA were assessed by RT-PCR or supernatants were used for cytokine measurement by ELISA.

## Chemotaxis assay

Cultured CD4 $^+$  T cells from C57BL/6 mice or CCR6KO mice were resuspended in complete RPMI-1640 medium and were loaded into collagen-coated Transwell devices (pore size, 5 mm; 3421; Corning) placed in 24-well plates containing medium alone or medium supplemented with 50 $\mu$ g/ml WT-IDEN or APC-IDEN. After plates had incubated at 37°C for 4 h, cells that had migrated were collected, counted and stained with mAb to determine the number of migrated CD4 $^+$  T cells by flow cytometry. The ratio of the number of CD4 $^+$  T cells that migrated in the presence of IDENs to the number of cells that migrated to control media was calculated and is presented as the percentage of migrated cells relative to the input.

## **Anti-CD3 antibody treatment**

Mice were injected with anti-CD3 (20  $\mu$ g/mouse, Bio  $\times$  cell, 145 2C11)<sup>1</sup> intraperitoneally three times at an interval of 2 days between injections and killed 4 h after the final injection.

In some experiments, mice were co-treated with COX2 inhibitor indomethacin (3mg/kg of body weight) or celecoxib (15mg/kg of body weight) by intraperitoneal injection.

## Sphingolipid analysis

Ceramide species, sphingosine and S1P from IDEN and tumor exosmes were collected and analyzed using a S1P ELISA kit (Mybiosource, #MBS094198) or with LC-MS/MS by the Lipidomics Shared Resource, (Medical University of South Carolina), as previously described<sup>48</sup>. Briefly, calibration curves were constructed by plotting peak area ratios of synthetic standards corresponding to each target analyte with respect to the appropriate internal standard. The target analyte peak areas from the samples were similarly normalized to their respective internal standard and then compared with the calibration curves using a linear regression model. Results were normalized to total protein levels

## Statistical analysis

Multiple comparisons were analyzed by 1-way ANOVA and Fisher's protected least significant difference test. A t-test was used to compare the means of two groups. P values of less than 0.05 were considered to be statistically significant.




Figure 1. Proposed pathways lead to overproduction of CD4<sup>+</sup>CCR6<sup>+</sup>IL17A<sup>+</sup>




Figure 2. ET-BSPs and S1P upregulate genes that encode sphingolipids and chemokines Molecules expressed in MC38 cells (A and B). MC38 colon cancer cells were cultured with BSA, NT-BSPs or ET-BSPs (20 µg/ml) (A) or with vehicle/S1P (B) for 18 h. Real-time PCR analysis of gene expression (A; B, left panel) and ELISA analysis of PGE2 (right panel) in the supernatants. The data represent means  $\pm$  SEMs.  $^*p < 0.05, \, ^{**}p < 0.01$  (Student's t-test). (C) MC38 cells were cultured with conditioned medium from colonic macrophages treated with BSA, NT-BSPs or ET-BSPs, and the expression of the indicated genes was measured by qPCR. The data represent means  $\pm$  SEMs (n = 5).  $^*p < 0.05, \, ^{**}p < 0.01$  (Student's t-test).





Figure 3. Bacteria-secreted particles mediate the induction of CCL20+PGE2+S1P+ exosomes (A–B) MC38 cells were cultured with conditioned medium (CM) from macrophages treated with BSA, NT-BSPs or ET-BSPs (20 µg/ml), and the levels of SPH (A) and CCL20 (B) in tumor exosomes were assessed by LC-MS/MS (A) or Western blot (B). The data represent means  $\pm$  SEMs (n = 5). \*p < 0.05, \*\*p < 0.01 (Student's t-test). (C) Changes in the ratio of S1P and PGE2 in exosomes released from MC38 cells pretreated with BSA, NT-BSPs or ET-BSPs in the absence or presence of SphK1 inhibitor (SK1-I, 5 µM) for 48 h. The data represent means  $\pm$  SEMs. \*\*p < 0.01 (Student's t-test). (D) Western blot analysis of CCL20 in exosomes derived from (C).







Figure 4. ET-Tumor<sup>EXO</sup> accelerates tumor growth by modulating Stat3 signaling (A–C) C57BL/6 mice were orthotopically implanted with MC38-luc cells with exosomes by colonic submucosal injection. Colonoscopy image of implanted MC38-luc cells at day 18 after injection (A), photon flux from C57BL/6 mice harboring MC38-luc tumors (B), and H&E-stained colon sections (C). The data (B) represent means  $\pm$  SEMs \*\*p < 0.01






**Figure 6.** APC-IDENs and macrophage APC-IDEN+ recruit CCR6+CD4+Th17+ to the gut (A-C) Confocal images of F4/80 immuno-stained frozen colon sections prepared 5 h after gavaging mice with PKH26-labeled IDENs (red). Non-tumor (A) and tumor (B) colon






**Figure 7.** APC-IDEN PGE2 plays a role in the accumulation of intestinal CD4<sup>+</sup>Th17<sup>+</sup> cells (A) ELISA analysis of PGE2 in IDENs isolated from WT, APC<sup>min/+</sup> or CAC mice.

The data represent means  $\pm$  SEMs (n=5). \*p < 0.05, \*\*p < 0.005 (Student's t-test).








Figure 8. MyD88 plays a role in the APC-IDEN-mediated induction of CCR6<sup>+</sup>CD4<sup>+</sup>Th17<sup>+</sup> cells (A) Electron microscopy images of IDENs in the colons of wild-type B6 mice. (B-C) Confocal images of 16S RNA and CD63. CD63 (red) and bacterial 16S RNA (green) inhabiting loose mucous layers in colon tissue (B) and APCmin/+ lymphoid follicles (C). (D–E) Confocal images of APC<sup>min/+</sup> mouse CD63 in the epithelial lumen (D; top), the lumen of the crypts (D; bottom) and tumor tissue (E). (F-G) WT and MyD88<sup>-/-</sup> mice were treated with CD3-specific antibodies. FACS analysis of PKH26<sup>+</sup> cells in the peripheral blood after gavage with PKH26-labeled IDENs (F), confocal images of small intestine sections stained with mucin-2-specific antibody (G). (H-I) Under Th17 cell culture conditions, naïve CD4+ T cells were cultured in the presence of BSA or IDENs. FACS analysis of the induced chemokine receptors (H) and ELISA of the production of cytokines (I). (J) ELISA analysis of IDEN PGE2 (Left panel) and real-time PCR analysis of COX2 (Middle panel) from the small intestine, and a Western blot analysis of CCL20 in IDENs from mice treated with CD3-specific antibody (Right panel). The data (I and J) represent means  $\pm$  SEMs (n=3). \*\*p < 0.01 (Student's t-test).
