Life sciences study design

Sample size Typically several thousands of cells were selected for the analysis in each experimental condition. The number was chosen at random, depending on the density of the number of cells per image position Typically up to few thousands of cells are reported in similar replisome studies.

Data exclusions Imaging data were excluded if the detected DnaN foci failed with a Gaussian fitting, for instance, zero amplitude, extreme small (<1) or large (>3) sigma values, or low signal-to-noise ratio (amplitude/offset< 0.25).

Replication Each experiment was reproduced with three biological repeats. All replications were successful.

Randomization Samples were allocated to experimental groups based on the growth conditions (growth temperature, growth media, presence of antibiotics etc.) used. No randomization was not relevant.

Blinding Blinding was not performed, because depending on the growth conditions (growth temperature, growth media, presence of antibiotics) the cell morphology and physiology were clearly different between cells, making the blinding not possible.
