Persisting Neutralizing Activity to SARS-CoV-2 over Months in Sera of COVID-19 Patients

Abstract: The relationship between the nasopharyngeal virus load, IgA and IgG antibodies to both the S1-RBD-protein and the N-protein, as well as the neutralizing activity (NAbs) against SARS-CoV-2 in the blood of moderately afflicted COVID-19 patients, needs further longitudinal investigation. Several new serological methods to examine these parameters were developed, validated and applied in three patients of a family which underwent an ambulatory course of COVID-19 for six months. The virus load had almost completely disappeared after about four weeks. Serum IgA levels to the S1-RBD-protein and, to a lesser extent, to the N-protein, peaked about three weeks after clinical disease onset but declined soon thereafter. IgG levels rose continuously, reaching a plateau at approximately six weeks, and stayed elevated over the observation period. Virus-neutralizing activity reached a peak about 4 weeks after disease onset but dropped slowly. The longitudinal associations of virus neutralization and the serological immune response suggest immunity in patients even after a mild clinical course of COVID-19.

1. Introduction

According to our current understanding, coronavirus SARS-CoV-2, which causes COVID-19 [1,2], is transmitted among humans via droplets from the respiratory tract. The high level of contagiousness of SARS-CoV-2 is probably related to a high virus load in human sputum on the one hand, and to the protective effect of proteins against virus material in the respiratory tract on the other. In a recent cell culture study, SARS-CoV-2 was isolated from the saliva of individuals over a period of two weeks after the onset of a symptomatic infection [3]. The study provides information about the

excretion of the virus in the sputum and stool of severely ill, hospitalized patients. Further data from moderately ill patients, however, are important in terms of the length of time over which SARS-CoV-2 is excreted into the respiratory tract of these patients. Such data are important to know since most of the infections are mild, especially in young patients. Furthermore, little is known about the course of the immune response with regard to the various types of antibodies against SARS-CoV-2 proteins and their virus-neutralizing potential over a prolonged period of time.

Here, we report on the extent of SARS-CoV-2 RNA present in nasal and oro-pharyngeal fluid, as well as on the level of IgG and IgA antibodies against the S1-RBD-protein and the N-protein of SARS-CoV-2 in blood, and their ability to neutralize SARS-CoV-2 in vitro. The samples from three patients belonging to the same family were examined over a period of half a year, starting with the onset of the disease.

2. Materials and Methods

2.1. Ethics

Experiments conformed to the Declaration of Helsinki Principles. Written, informed consents were obtained from all blood donors prior to the study. The study was approved by the Independent Research Ethics Committee (IEC) of the University of Tuebingen, IEC-Project Number 672/2020A.

2.2. Patients

All patients are related and live in the same household. *Patient 1*: Adult male. Coughing is the first symptom, lasting until day 8 after onset of disease. Fever (38.1 °C) on days 2 and 3. Symptoms on days 2–8 include headache, muscle pain in arms and legs and tiredness. Apart from occasional coughing after day 8, the patient's well-being improves until full recovery of health is reached. *Patient 2:* Adult female. Coughing is the first symptom, occurring three days after disease onset in patient 1, followed by elevated body temperature (37–38 °C) on days 4 and 5. Headache and limb pain occur on days 2–8. Persistent tiredness since day 4 and anosmia from day 5–13, with subsequent full recovery. *Patient 3:* Adult female. Three days after patient 1 she began coughing, had elevated temperature (37–38 °C) on days 2 and 3, muscle pain on day 3, rhinitis on days 5–7, and hyposmia on days 2–8. She recovered fully by day 8.

In each of the patients, SARS-CoV-2 RNA had been diagnosed via nasal and oro-pharyngeal fluids, with testing conducted in a commercial diagnostic laboratory on day 1, when the first symptoms had presented. A quantification of the virus load in these specific samples is not available.

In our study, blood samples were taken from patients over more than 6 months at the following time points (t1–t12): patient 1: on days 13 (t1), 20 (t2), 25 (t3), 33 (t4), 40 (t5) 48 (t6), 60 (t7), 74 (t8), 109 (t9), 137 (t10), 165 (t11) and 193 (t12) after onset of symptoms; patient 2: on days 10 (t1), 17 (t2), 22 (t3), 30 (t4), 37 (t5), 45 (t6), 57 (t7), 71 (t8), 106 (t9), 134 (t10), 162 (t11) and 190 (t12) after experiencing first symptoms; and patient 3: on days 11 (t1), 18 (t2), 23 (t3), 31 (t4), 38 (t5), 46 (t6), 58 (t7), 72 (t8), 107 (t9), 135 (t10), 163 (t11) and 191 (t12) days after onset of symptoms.

Nasopharyngeal samples were taken from patients at t1–t5, and t9.

2.3. Methods

2.3.1. SARS-CoV-2 RT-qPCR

The virus RNA was isolated from swab samples using a High Pure Viral Nucleic Acid Kit (Roche, Mannheim, Germany)) as follows: each swab was incubated for 10 min at 70 °C in 350 μ L binding buffer, 50 μ L proteinase K and 4 μ L poly(A)-RNA. After the addition of 250 μ L of phosphate-buffered saline, samples were mixed by vigorous vortexing, after which a 600 μ L sample was processed according to the manufacturer's specifications. Nucleic acids were eluted in 50 μ L of elution buffer; 5 μ L of the eluted sample was examined in a total RT-qPCR reaction volume of 20 μ L, according

to the manufacturer's specifications, using LightCycler 480 (Roche) instrumentation. The detection of SARS-CoV-2 RNA was conducted by means of the SARS-CoV-2-realDETECT kit (Mediagnost GmbH, Reutlingen, Germany). Amplifications of the E gene and the human RNase-P control were carried out in multiplex RT-qPCR [4] reactions. A recombinant in vitro-transcribed RNA standard (4BLqSARS-CoV 2-RNA, CO301001, 4base lab AG, Reutlingen, Germany) encoding the SARS-CoV-2 primer and probe-binding sites described by Corman et al. [4] and the Centers for Disease Control and Prevention, USA [5] was applied for quantification.

2.3.2. Detection of IgA and IgG Antibodies against SARS-CoV-2-S1-RBD-Protein

IgG Antibody Assay: The ELISA test system E 111-IVD developed by Mediagnost GmbH, Reutlingen, Germany was employed according to the manufacturer's instructions. This test system is a two-step enzyme-linked immunosorbent assay for the detection of IgG antibodies directed against SARS-CoV-2 S1, specifically targeting the receptor-binding domain (RBD) protein. The solid phase consists of a 96-well microtiter plate (Greiner Bio One, Frickenhausen, Germany) that is coated with the $recombinant \, SARS\text{-}CoV\text{-}2\text{-}S1\text{-}RBD\text{-}protein. \ Briefly, the test methodology can be described as follows:}$ antibodies from patients' serum that are directed against the SARS-CoV-2-S1-RBD-protein bind to the immobilized antigen. Next, a horseradish peroxidase (HRP) conjugated goat anti-human IgG binds to the human IgG antibodies. The following step involves the substrate for the HRP being added, by which the substrate is converted by HRP from colorless into blue; after the addition of a stop solution, the color changes to yellow. The extinctions of the yellow solution can be measured at a wavelength of 450 nm, with reference at 620 nm. The lower threshold is determined by using human serum without antibodies against SARS-CoV-2; the cut-off towards positive values was estimated by using the extinction value as the negative control times five. Thus, samples showing extinctions that were five times higher than the negative control can be interpreted as being positive for anti-SARS-CoV-2 S1. Increasing extinctions represent increasing amounts of antibodies to SARS-CoV-2 S1 protein. The specificity was substantiated by means of sera containing high levels of antibodies against other viral diseases—such as the hepatitis viruses A, B and C, Epstein–Barr virus, cytomegalovirus, influenza viruses A and B, varicella zoster virus and human herpes simplex virus type 1—as determined at the Institute for Medical Virology and Epidemiology and the Institute for Pathology and Neuropathology of the University of Tuebingen, Germany. The results for each of the tested sera were negative in terms of antibodies against the SARS-CoV-2 S1 protein. Serum from patients infected with other human coronaviruses such as HKU-1 and NL63 also proved to be negative.

IgA Antibody Assay: The ELISA test system for the detection of IgA antibodies to SARS-CoV-2 S1-RBD protein was analogous to the anti-SARS-CoV-2 IgG ELISA, except that the HRP-labeled detection antibody was directed against human IgA antibodies.

IgA and IgG assays for the determination of antibodies to the SARS-CoV-2 nucleoprotein (N-protein) in sera were developed in analogy to the assays for anti-SARS-CoV-2-S1-RBD-protein as described above. The first step in these assays involves the SARS-CoV-2 N-protein being bound to the solid phase.

2.3.3. Virus Neutralization Assay (VNA)

By means of the VNA, we quantified in vitro the ability of human sera from patients to inhibit the infection of human cells Caco-2 (human colorectal adenocarcinoma) with a strain of SARS-CoV-2 virus. The SARS-CoV-2 strain icSARS-CoV-2-mNG [6] was obtained from the World Reference Center for Emerging Viruses and Arboviruses (WRCEVA) of the UTMB (University of Texas Medical Branch). To generate icSARS-CoV-2-mNG stocks, Caco2 cells were infected, the supernatant was harvested 48 h post-infection, centrifuged and stored at $-80\,^{\circ}$ C. For MOI (multiplicity of infection) determination, a titration using serial dilutions of the virus stock was conducted. The number of infectious virus particles per ml was calculated as the (MOI \times cell number)/(infection volume), where MOI = $-\ln (1 - \text{infection rate})$.

For neutralization experiments, 1×10^4 Caco-2 cells/well were seeded in 96-well plates the day before infection, in media containing 5% FBS. Cells were infected with the SARS-CoV-2 strain icSARS-CoV-2-mNG at a MOI = 1 or mock-infected. Immediately after infection, serum for COVID-19 patients was added to each well in two-fold serial dilutions from 1:40 up to 1:5120. The cells were fixed 48 h post infection with 2% PFA and stained with Hoechst 33,342 (1 μ g/mL final concentration) for 10 min at 37 °C. The staining and fixing solution was then removed, after which PBS was added. In order to quantify the infection rates, images were taken with the Cytation3 (Biotek, Hoechst, Germany), and mNG+ cells were automatically counted by the Gen5 Software (Biotek). Titers of neutralizing antibodies (NAbs) were calculated as the half-maximal inhibitory dose (ID50) using 4-parameter nonlinear regression (GraphPad Prism).

3. Results




Figure 1. Time course of SARS-CoV-2 RNA detection in nasal and oro-pharyngeal swabs of three clinically ill patients.

The results shown here represent the mean of two independent test series. The numbers of SARS-CoV-2 RNA copies in swab samples observed over approximately five weeks, starting with the onset of COVID-19 symptoms in our patients, are illustrated in Figure 1.

In each of the patients, the amount of virus RNA was highest about one week after the onset of symptoms, with a decline in several orders of magnitude following thereafter. Within a short period of 31 days (patient 3), 37 days (patient 2) and 40 days (Patient 1), virus RNA was no longer detectable in nasal and oro-pharyngeal fluid. All sera taken from the patients revealed negative RT-qPCR results for SARS-CoV-2 RNA, suggesting the absence of viremia.




Figure 2. (a–h): Serum antibodies to SARS-CoV-2 S-protein (IgA; IgG) and serum virus neutralizing activity (NAbs) in individual patients over time (a–c). Averaged levels of the three patients are illustrated in d—serum antibodies to SARS-CoV-2 N-protein (IgA; IgG) and serum virus neutralizing activity (NAbs) in individual patients over time (e–g). Averaged levels of the three patients are illustrated in h.

The results of the levels of anti-SARS-CoV-2 S1-RBD antibodies and the anti-SARS-CoV-2 N antibodies—IgA and IgG—expressed in terms of the absorbance (see Methods), and the titers of the virus-neutralizing antibodies (NAbs), expressed as the half-maximal inhibitory dose (ID50) during the observation phase, are illustrated in Figure 2a–h.

The course of the antibodies (Abs) against the two different regions of SARS CoV-2, the S1-RBD protein and the N-protein and the NAbs in the three affected individuals show a characteristic pattern. All patients exhibited an early rise in the IgA Abs against S1-RBD-protein and N-protein, which peaked around three weeks (t2–t3) and subsequently declined to basal levels at around five weeks (t5). Quantitatively, the response of IgA-Abs was most profound in patient 2, who also had the most severe clinical course. Changes in IgG Ab levels against S1-RBD-protein or N-protein were qualitatively similar but showed a different dynamic. While anti-S1-RBD IgG-Abs rose slowly from the beginning, reaching a maximum at around five weeks after disease onset (t4–t5), they remained elevated at a high

level, whereas the anti-N IgG-Abs had already increased at around two weeks (t1) in all patients and rose further thereafter. Again, patient 2 showed the highest levels. The course of NAbs in the patients was time-dependent and qualitatively similar in both types of Abs against the virus S1-RBD-protein.

Marked virus-neutralizing activity was observed as early as week 3 (t2) and rose further by about 6 weeks (t4–t5). However, a decline followed, and markedly lower yet positive levels were recorded at around ten weeks after disease onset (t7–t8). Again, patient 2 showed the highest levels.

4. Discussion

In a recent review [7], the acute antibody mediated response to Coronaviruses was described in detail. Here, we describe with three patients the virus excretion and the antibody response over a period of half a year after the acute phase of the disease.

Our observational study was based on the premise that it would be clinically relevant to investigate the virus load of SARS-CoV-2 along with the development of various antibodies against different regions of the virus, as well as study the virus-neutralizing activity longitudinally. The study was conducted with newly developed methods in three patients who suffered from a moderately severe course of COVID-19 over a period of about six months.

The clinical course of COVID-19 in these patients turned out to be relatively mild, and all three patients recovered after approximately two weeks after symptoms manifested. We were able to detect SARS-CoV-2 RNA over a period of four weeks after onset of symptoms, as evidenced by the significant numbers of RNA genome equivalents in the swabs of the three patients we studied. Even at days 30 and 33 after onset, low amounts of the SARS-CoV-2 genome could be detected in two patients, whereas in the third patient, the virus had meanwhile cleared. On days 37, 38 and 40 (Figure 1), complete clearance of the virus was confirmed in all three patients. Our data on the length of time during which SARS-CoV-2 RNA was measurable in the nasal and oro-pharyngeal fluids of patients in this case study inevitably lead to the question about the possible duration of infectivity in post-symptomatic patients. Since the viral load threshold for the transmission of SARS-CoV-2 between humans is yet unknown, it is not possible to predict the impact of close contact between non-immune persons and patients deemed clinically recovered from COVID-19. In addition to other innovative strategies to avoid virus transmission in institutional settings [8], the policy of social distancing thus still remains appropriate until complete clearance of SARS-CoV-2 is established. It can well be assumed that SARS-CoV-2 RNA clearance probably indicates the absence of infectivity in recovered SARS-CoV-2 patients [4,9,10]. In a recent study [11], it was reported that the transmission of COVID-19 infections within households is the most important which is confirmed by our results.

In a recent study [6] of hospitalized COVID-19 patients, it was demonstrated that, in nasal and oro-pharyngeal fluid deriving from swabs, high numbers of RNA copies of SARS-CoV-2 could be detected after the onset of symptoms, followed by rapidly decreasing amounts in the subsequent three weeks. These authors also showed that SARS-CoV-2 from swabs could be isolated in cell culture for up to 8 days after disease onset. By measuring anti-SARS-CoV-2 proteins (IgA and IgG) and using a virus-neutralization assay, the authors also confirmed that seroconversion had occurred in all patients after 14 days.

It has been postulated that the infection of susceptible human target-cells by SARS-CoV-2 occurs via attachment of the receptor binding domain (RBD) of the S1 protein of the virus to the ACE2 receptor of targeted cells, mainly in the respiratory tract [12,13]. It is assumed that by blocking the attachment of the virus to the receptor, an infection could potentially be inhibited. It was on these grounds that assays were developed for determining human antibodies against this domain of the S1 protein. For diagnostic purposes, however, the detection of antibodies directed against other viral proteins such as the nucleoprotein (N-protein) may also be important, since the N-protein is the most abundant protein in the viral particle [14]. On the other hand, the immunogenicity of an antibody protein may not only be associated with its nature and amount, but also with its effects on the cellular immune response to the virus [11].

It is common knowledge that, after infections, various immunoglobulins are produced in a certain time sequence. Initially, immunoglobulins of the IgM class occur, and, after several weeks, immunoglobulins of the IgG class appear in blood. While immunoglobulins of the IgA class are also measurable in blood, they also occur in saliva, where their primary role is to counteract infectious agents. We primarily focused on measuring antibodies to SARS CoV-2 of the IgG class. The investigation of IgA antibodies has come into focus more recently, after anti-SARS-CoV-2 IgA antibodies in blood were described to be associated with the early immune response to COVID-19 in patients [15].

The investigation of IgG and IgA levels against the two SARS-CoV-2 proteins in blood shows qualitative similarities but quantitative differences in the patients' data over time. Interestingly, the patient with the relatively more severe course than the other two patients showed the highest levels of both Abs. This raises two important questions: (1) Do antibodies have virus-neutralizing activity? (2) Are patients who survive COVID-19 immune to a re-infection in the long term? While it is often the case that anti-viral antibodies are protective, this is not always the case, as is evident after an infection with the Dengue virus [16]. In some instances, the antibodies formed may even have an exacerbating effect on the course of the disease. This problem may be seen in reinfected patients in the future.

We decided to collect information on this subject and also measured the virus-neutralizing effect of sera over a period of six months in vitro. The course of the in vitro virus-neutralizing activity in the blood of our patients showed a common pattern: a measurably high virus load starts soon after the clinical onset of COVID-19, reaching a plateau in the weeks (t3–t6) thereafter, but showing a decline in all individuals after about two months. It is worth noting that serum-neutralizing capacity correlated with the abundance of IgA against the S1-RBD in the patients. Thus, even though it is clear that the ability of sera to neutralize SARS-CoV-2 depends on several antibody classes, it is possible that S1-specific IgA plays a major role.

Whether our measurements reflect the in vivo neutralizing capacity of an individual is yet unclear. However, these findings may indicate that the immunity is probably only transient in nature. Our observations of measurable neutralizing activity in sera of patients with mild infections over a period of more than half a year support the notion that the immunity against SARS-CoV-2 is persisting at least over several months. Our results are similar to recent findings in a large cohort of COVID-19 patients [17]. Corroborating evidence for this finding must be sought in similar, longitudinal investigations in future. Such investigations should focus on various indicators of the infectious process during and after recovery from COVID-19 with different clinical outcomes or after vaccination in larger cohorts of patients.
