THE TREATMENT OF THE SAC.

TO THE EDITOR, " INDIAN MEDICAL GAZETTE."

SIR,-Regarding the question "of the treatment of the sac in hernia operations," on which subject, you published an extract from my last annual report of the Khoorda Dispensary in your journal for April, together with your forms of hernia, I should like to add that the case treated by me was of the acquired variety ; it was an oversight on my part not stating this fact in my notes.

In your remarks regarding the treatment of the sac in this variety of hernia, you say "it either becomes a cyst similar to a hydrocele or hæmatocele "-I should be glad to know if there has been any practical demonstration of the former of these conditions arising, and if the bleeding points are efficiently dealt with-and this is particularly the wound, how do we get a hæmatocele ? Again, you say, "after removing the sac, the cavity occupied by it collapses, and if kept sweet and properly drained, heals in a week or ten days without any trouble."—Does this happy result always occur? I think I can remember at least one case in which the wound has healed by first intention, yet there has been troublesome inflammation of the scrotal tissues: up to this time. I have only on three occasions left the sac behind, so that my experience is limited, still in not one of these cases has there been anything like a hydrocele, hæmatocele nor any inflammation of the scrotal tissues ; so as regards the latter condition, I am bound to suspect the pulling and tearing of the tissues, necessary for separating the sac, as being the cause.

Again, I take it, there is just as much chance of suppuration and putrefaction arising whether the sac be left or be removed, neither condition being likely to supervene if strict attention be paid to antiseptic details, an attention I invariably pay.

Drainage was purposely omitted in my operation, so that the case should have a fair chance of answering my question.
