

# Bioinformatics analyses of differentially expressed genes associated with bisphosphonate-related osteonecrosis of the jaw in patients with multiple myeloma

**Purpose:** This study aimed to explore the molecular mechanisms associated with bisphosphonate (BP)-related osteonecrosis of the jaw (ONJ) in patients with multiple myeloma (MM).

**Methods:** The gene expression profile GSE7116 was downloaded from the Gene Expression Omnibus database. Differentially expressed genes (DEGs) from eleven patients with ONJ resulting from MM treated with BPs (ONJBPs) and ten MM patients without ONJ treated with BPs (MMBPs) were analyzed. Gene ontology (GO) and pathway enrichment analyses of DEGs were performed, followed by functional annotation and protein–protein interaction network construction. Finally, sub-network modules were constructed and analyzed.

**Results:** A total of 166 up- and 473 down-regulated DEGs were identified. The up-regulated DEGs were enriched in pathways related to cancer, and the down-regulated DEGs were enriched in pathways related to the immune system. Moreover, the GO terms enriched by the up-regulated DEGs were associated with misfolded proteins, and the down-regulated DEGs were associated with immune responses. After functional annotation, 16 transcription factors were identified, including X-box binding protein 1 (XBP1). In protein–protein interaction network analysis, tumor necrosis factor (*TNF*) and interleukin 1, beta (*IL1B*) had higher connectivity degrees. Among the constructed sub-network modules, module 1 was the best one, and DEAD (Asp-Glu-Ala-Asp) box helicase 5 (*DDX5*) was a hub gene. The DEGs in module 1 were mainly enriched in GO terms related to RNA splicing.

**Conclusion:** DEGs of ONJ were mainly enriched in pathways related to the immune system and RNA splicing. DEGs such as *TNF*, *IL1B*, *DDX5*, and *XBP1* may be the potential targets of ONJ treatment.

## Introduction

Multiple myeloma (MM), a neoplasm of plasma cells, is a presently incurable hematological malignancy affecting one to five per 100,000 individuals each year worldwide.<sup>1,2</sup> Frequently, there is invasion of the adjacent bone, which destroys skeletal structures and results in bone pain and fractures.<sup>3</sup> Bisphosphonates (BPs) are synthetic analogs of naturally occurring pyrophosphates, which are capable of localizing to the bone and inhibiting osteoclastic function.<sup>4</sup> BPs have been approved by other studies for the treatment of MM and solid tumors.<sup>5,6</sup> However, a complication, avascular osteonecrosis of the jaw (ONJ), has recently been described as associated with their use.<sup>4,7</sup>

Osteonecrosis refers to the death of bone as a result of impaired blood supply.<sup>8</sup> ONJ results from bone exposure in the oral cavity, with subsequent necrosis often following dental procedures or traumatic injuries.<sup>9</sup> ONJ has been described in association with the use of zoledronic acid and pamidronate in various malignancies.<sup>4,10</sup> Currently, the exact mechanism of this BP-mediated osteonecrosis is not certain, and it is likely multifactorial. Age, smoking, obesity, cancer diagnosis, and poor oral health have been shown to be predisposing factors for ONJ.<sup>11</sup> Previous studies suggest that genetic factors could also be involved in BP-mediated ONJ risk.<sup>12,13</sup> For example, Such et al published a study showing that the presence of one or two minor alleles of the cytochrome P450, subfamily 2C, polypeptide 8 gene was an independent prognostic marker associated with development of ONJ in MM patients treated with BPs.<sup>12</sup> Nicoletti et al reported that RNA binding motif, single-stranded interacting protein 3, is significantly associated with BP-related ONJ.<sup>13</sup> Progress in understanding the mechanisms of BP-mediated ONJ in patients with MM will contribute to solutions for this complication. However, our present knowledge is insufficient.

In the present study, we applied a biological informatics approach to analyze the gene expression profiles of GSE7116, and we performed functional analysis for differentially expressed genes (DEGs) between patients with ONJ resulting from MM treated with BPs (ONJBPs) and MM patients treated with BPs without ONJ (MMBPs). Additionally, functional enrichment and functional annotations were analyzed, and a protein–protein interaction (PPI) network was constructed. We aimed to provide a systematic perspective toward understanding underlying mechanisms and toward discovering new therapeutic targets for the treatment of ONJ.

## Methods

### Affymetrix microarray data

The raw CEL array data of GSE7116 were downloaded from the Gene Expression Omnibus (GEO; <http://www.ncbi.nlm.nih.gov/geo/>) database based on the platform of the GPL570 [HG-U133\_Plus\_2] Affymetrix Human Genome U133 Plus 2.0 Array, which was deposited by Raje et al.<sup>14</sup> The database contains 26 samples, including eleven samples of ONJBP, ten samples of MMBP, and five samples from normal donors. In this paper, the ONJBP and MMBP samples were used for the development of the Affymetrix microarray data.

### Data preprocessing and differential expression analysis

The original array data were converted into expression measures, and we performed background correction,

quartile data normalization, and probe summarization with the robust multi-array average (RMA)<sup>15</sup> algorithm in the R Affy<sup>16</sup> package.

Paired *t*-tests based on the multitest package in R were used to identify genes that were significantly differentially expressed between the ONJBP and MMBP samples. The log<sub>2</sub>-fold change (log<sub>2</sub>FC) was calculated. Only |log<sub>2</sub>FC| >0.58 and false discovery rate (FDR) <0.05 results were considered as the cutoff value for DEG screening.

### Gene ontology and pathway enrichment analyses

Gene ontology (GO)<sup>17</sup> is a tool for the unification of biology that is used to collect a structured, defined, controlled vocabulary for a large scale system of gene annotation. The Kyoto Encyclopedia of Genes and Genomes (KEGG)<sup>18</sup> knowledge database is a collection of online databases dealing with genomes, enzymatic pathways, and biological chemicals. REACTOME<sup>19</sup> is a curated, peer-reviewed pathway database of human biological processes. The Database for Annotation, Visualization and Integrated Discovery (DAVID),<sup>20</sup> has been developed as a comprehensive set of functional annotation tools for relating the functional terms with gene lists using a clustering algorithm. To analyze DEGs at the functional level, we performed GO, KEGG, and REACTOME pathway enrichment analyses using the DAVID online tool to obtain the enriched biological process, molecular functions (MFs), cellular component (CC) terms, and pathways. A *P*-value <0.01 was set as the threshold value.

### Functional annotation of DEGs

Based on the data-driven transcription factors (TFs), the DEGs were selected and annotated to determine whether these genes had functions related to transcriptional regulation. The Tumor Suppressor Gene (TSGene) database<sup>21</sup> integrates tumor suppressor genes (TSGs) with large-scale experimental evidence to provide a comprehensive resource for the further investigation of TSGs and their molecular mechanisms in cancer. The Tumor-associated Gene (TAG) database<sup>22</sup> is used to save new tumor-associated genes (TAGs) that play roles in carcinogenesis. In the current study, we extracted all the known oncogenes and TSGs from the TSGene and TAG databases.

### PPI network construction and sub-network identification

The Search Tool for the Retrieval of Interacting Genes (STRING) database<sup>23</sup> is a pre-computed global resource, which has been designed to evaluate PPI information.

In a PPI network, each node stands for a gene, and the edges represent the interactions between nodes. Degree indicates the number of edges linked to a given node, and nodes with high degree are defined as hub genes that possess important biological functions. In the present research, the STRING online tool was applied to analyze the PPI network of DEGs, and only those experimentally validated interactions with a combined degree  $>0.7$  were selected as significant.

Cytoscape<sup>24</sup> is a general bioinformatics package used for visualizing biological network and integrating data. Clustering with overlapping neighborhood expansion (ClusterONE)<sup>25</sup> is used to discover densely connected and possibly overlapping regions within a PPI network. In the current study, ClusterONE, based on Cytoscape, was used to identify sub-networks in the PPI network. Then, GO functional and pathway enrichment analyses were performed with a *P*-value  $<0.01$ .

## Results

### Identification of DEGs

For the dataset GSE7116, a total of 1,920 transcripts were obtained after data preprocessing. Among them, 449 were up-regulated transcripts, which corresponded to 166 DEGs and 1,471 down-regulated transcripts corresponding to 473 DEGs.

### GO and pathway enrichment analyses

After GO functional enrichment analysis, the DEGs were enriched in three categories including biological process, MF, and CC. The top three GO terms of the three categories are shown in Table 1. The up-regulated DEGs mainly participated in the GO terms related to misfolded proteins, while the down-regulated DEGs mainly participated in the GO terms related to the immune system.

The significantly enriched KEGG and REACTOME pathways of the up-regulated DEGs and down-regulated DEGs are shown in Table 2. The up-regulated DEGs were enriched in 13 KEGG pathways, such as bladder cancer, non-small cell lung cancer, and six REACTOME pathways, such as constitutive PI3K/AKT signaling in cancer. The down-regulated DEGs were enriched in 72 KEGG pathways, such as Leishmaniasis and T cell receptor signaling pathways, and 230 REACTOME pathways, such as pathways related to the immune system and the adaptive immune system.

### Functional annotation of DEGs

After researching the expression of TFs and TAGs, four TFs were up-regulated, including POU class 2 homeobox 2 and C-terminal binding protein 2, and 12 TFs were down-regulated, including X-box binding protein 1 (XBP1) and MYC-associated factor X. In addition, in the up-regulated DEGs, three were oncogenes, four were TSGs, and the functions of the other three

DEGs were uncertain. In the down-regulated DEGs, 49 genes were TAGs. Among these DEGs, 13 were oncogenes, 21 were TSGs, and the functions of other 15 were uncertain.

## PPI network construction

Based on the STRING database, PPI networks with a degree of more than 15 were then constructed using Cytoscape, and networks with 281 nodes and 643 edges were obtained (Figure 1). Fifteen nodes were selected as hub genes with a degree >15, including mitogen-activated protein kinase 1 (degree =30), tumor necrosis factor (*TNF*, degree =20), and interleukin 1, beta (*IL1B*, degree =17).

## Sub-network identification and functional enrichment analysis

After clustering analysis of the PPI network using Cluster-ONE, we obtained 42 sub-network modules, among which module 1 was the best descriptor with 12 nodes and 40 edges (Figure 2). Heterogeneous nuclear ribonucleoprotein K (degree =10) and DEAD (Asp-Glu-Ala-Asp) box helicase 5 (*DDX5*, degree =4) had higher degrees in module 1.

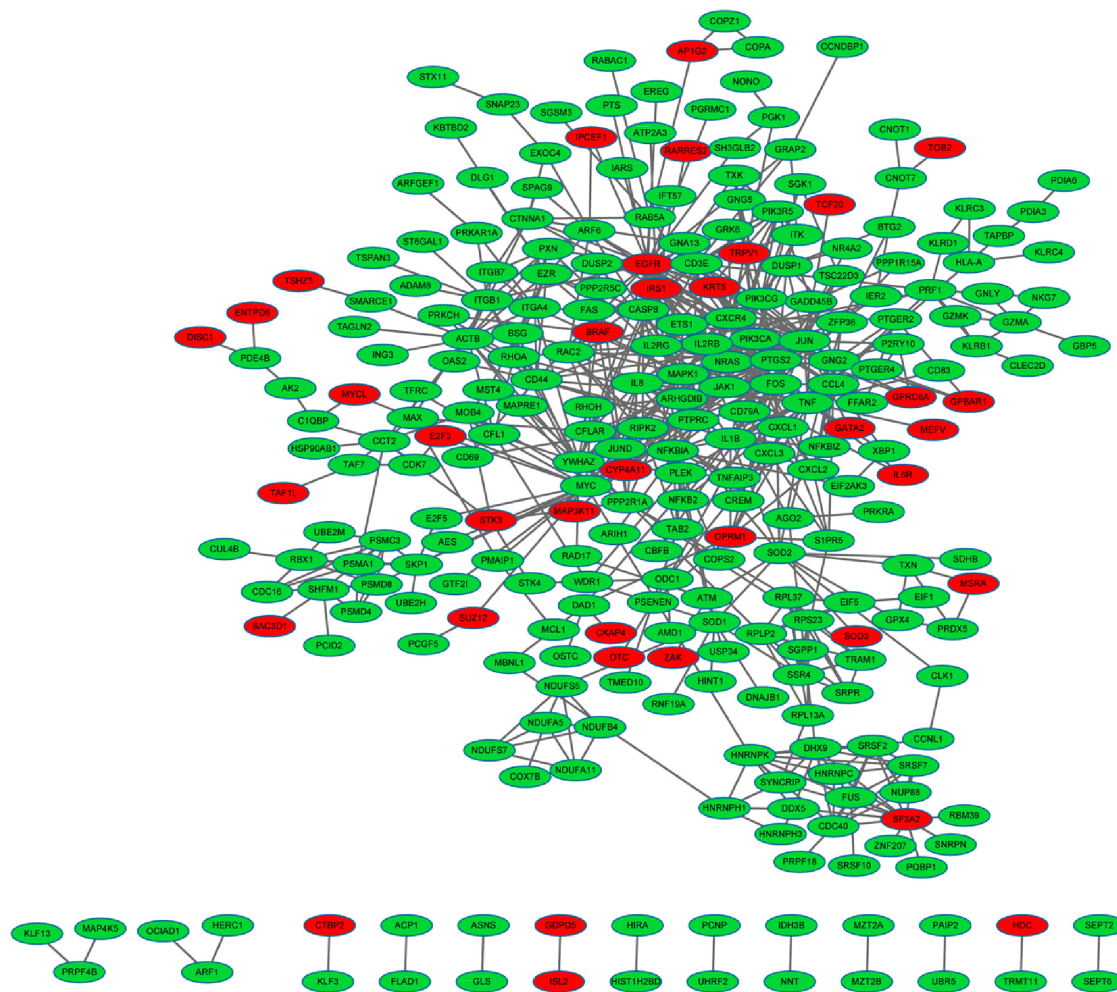
After GO functional and KEGG pathway enrichment analyses of the DEGs in module 1, we found that these DEGs were mainly enriched in GO terms associated with RNA splicing and pathways of spliceosomes.

## Discussion

Although BPs have been associated with ONJ, their role in its pathophysiology remains to be defined.<sup>26</sup> Our current analysis of the gene expression profile revealed the underlying gene activity changes related to ONJ and enabled the identification

of targets for management policy. In the present study, a total of 639 DEGs were identified as differing between ONJBP and MMBP samples through the gene expression profile of GSE7116. The down-regulated DEGs were enriched in pathways related to the immune system and biological process terms related to RNA splicing. In the PPI network and sub-network, the hub genes *TNF*, *IL1B*, and *DDX5* had higher connectivity degrees. Additionally, TF of XBP1 was also found to be down-regulated. These results suggested that these genes and pathways might play important roles in the progression of BP-mediated ONJ.

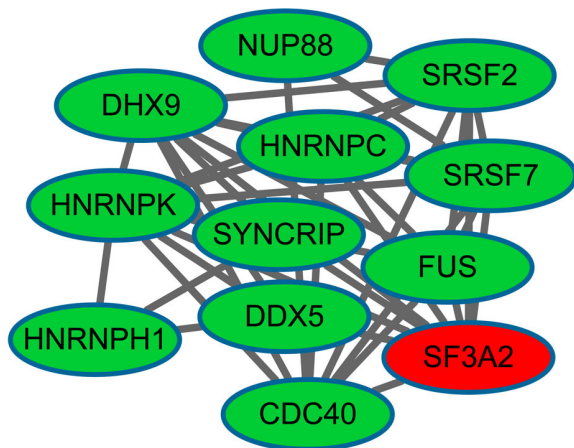
In the present study, pathways associated with the immune system were enriched by several down-regulated DEGs, such as *TNF* and *IL1B*, which had higher connective degrees in the PPI network. Forster showed evidence that BP therapy negatively affected the function and survival of neutrophils, which were key players in the immune system.<sup>27</sup> Another study reported that an immune defect may play a role in the pathophysiology of ONJ.<sup>28</sup> Thus, the immune system possibly contributes to the pathogenesis of ONJBP. *TNF* and *IL1B* are potent bone-resorbing cytokines that may contribute to the development of the osteolytic bone disease observed in patients with MM.<sup>29</sup> *TNF* encodes a multifunctional pro-inflammatory cytokine, and this cytokine is mainly secreted by macrophages. Importantly, *TNF* is involved in the regulation of a wide spectrum of biological processes, including cell proliferation, differentiation, and apoptosis.<sup>30</sup> Kast reported that *TNF* was a necessary growth factor for the expansion and maintenance of MM cells.<sup>31</sup> Tsimberidou et al also suggested that elevated *TNF-α* levels were associated with poor prognosis in patients with MM.<sup>32</sup>

The other cytokine, IL1B, is an important mediator of the inflammatory response, and it is involved in a variety of cellular activities, including cell proliferation, differentiation, and apoptosis.<sup>33</sup> In MM, IL1B contributes to myeloma

cell growth by an autocrine pathway.<sup>34</sup> Recently, Tai et al reported that IL1B was important in the pathogenesis of MM.<sup>35</sup> Additionally, a previous study found that concentrations of IL1B and TNF were significantly greater in patients with bone disease than in those without bone disease.<sup>36</sup> These observations suggest that TNF and IL1B play important roles in the disruption of bone homeostasis in various tumors, and that anti-TNF/IL1B may be used as candidate agents to prevent MM-induced osteolysis. Interestingly, BPs were found to have inhibitory actions on cytokine secretion by macrophages; as a result, they have inhibitory effects on TNF and IL1B.<sup>37</sup> In the present study, *TNF* and *IL1B* were down-regulated in the ONJBP samples, which was in accordance with the work done by Pennanen et al.<sup>37</sup>

In addition, BPs are pyrophosphate analogs with the addition of side chains, which bind to resorbing bone and are not metabolized. As a result, high concentrations will be maintained in bone for prolonged periods.<sup>38</sup> Specially, TNF- $\alpha$  and IL-1 are key cytokines in the processes of bone resorption and

osteoclast differentiation.<sup>38</sup> Therefore, we speculated that the residual BPs might result in the accumulation of microdamage and then affect the mechanical integrity of the bone by targeting *TNF* and *IL1B*. Taken together, *TNF* and *IL1B* (and the related pathways in which they participate) may be candidate molecular markers associated with BP-mediated ONJ.

It has been well documented that RNA splicing plays a biologically important function.<sup>39</sup> A previous study showed that RNA splicing occurs frequently in human cancer cells.<sup>40</sup> In our study, biological process terms related to RNA splicing were enriched by several down-regulated DEGs, such as *DDX5*. Moreover, *DDX5* was also a hub gene in the sub-network. The *DDX5* protein is a member of the DEAD-box (DDX) family of RNA helicases.<sup>41</sup> *DDX5* is involved in the alternative regulation of pre-mRNA splicing.<sup>42</sup> It is now well established that *DDX5* has the ability to stimulate cell proliferation and to prevent apoptosis.<sup>43</sup> At present, studies have reported that *DDX5* is overexpressed in human colon cancers and breast cancer, which strongly suggests that *DDX5* promotes tumorigenesis.<sup>44,45</sup> Importantly, Zhan et al demonstrated that *DDX5* was up-regulated in MM in relation to normal bone marrow.<sup>46</sup> As a result, we speculate that the down-regulation of *DDX5* in ONJBP may be caused by BPs. *DDX5* and the biological process terms related to RNA splicing may be key factors in ONJ.

We also found that the TF of XBP1 was down-regulated in the present study. This gene product is a basic-region leucine zipper protein that is also identified as a cellular TF, which binds to an enhancer in the promoter of the T cell leukemia virus type 1 promoter.<sup>47</sup> Inside the vascularized solid tumors, cells undergo endoplasmic reticulum stress, but they can survive in such adverse microenvironments by an adaptive mechanism called the unfolded protein response (UPR).<sup>48</sup> XBP1 is a critical transcriptional activator of the UPR, and it is responsible for regulating the functions of genes in cell survival.<sup>48</sup> Recent studies have implicated XBP1 overexpression in human carcinogenesis and tumor growth under hypoxic conditions; specifically, elevated XBP1 mRNA levels have been detected in hepatocellular carcinomas and breast tumors.<sup>49,50</sup> Additionally, the abundant expression of XBP1 has been detected in human MM cells.<sup>51</sup> A gene expression profiling study has also confirmed the specific expression of XBP1 in MM.<sup>46</sup> Therefore, compounds that target XBP1 may show therapeutic activity for the treatment of some cancers. In our study, the expression levels of XBP1 were found to decline in ONJBP samples, which suggests that XBP1 may play an important role in the progression of BP-related ONJ in patients with MM. Although there are few studies of the association

between XBP1 and ONJ, we can speculate that XBP1 may be an important TF related to BP-mediated ONJ.

Bioinformatics technologies have the potential to identify and validate candidate agents for serious diseases; however, the present study has a few limitations. The sample size for microarray analysis was small, which may cause a high rate of false positive results. Moreover, the current study lacked experimental verification. Further genetic and experimental studies with larger sample sizes are still needed to confirm our observations.

## Conclusion

In conclusion, our data provide a comprehensive set of bioinformatics analyses of DEGs that may be involved in BP-mediated ONJ. The findings in the current study may contribute to our understanding of the underlying molecular mechanisms of BP-mediated ONJ. DEGs such as *TNF*, *IL1B*, and *DDX5*, pathways associated with the immune system, and biological process terms related to RNA splicing, may have the potential to be used as targets for ONJ diagnosis and treatment. The identification of genetic factors in the management of this complication may result in safer long-term use of BPs in MM.
